CLERK

Minutes

Linda Fleming moved that the minutes of August 6, 2002 be approved as corrected. Lee Meacham seconded. The motion carried unanimously.

Bonds

Western Surety Company Bond No. 69210908 for Linda K. James of Rawlins as Treasurer of the Carbon County Visitors Council in the amount of \$20,000 was approved.

Western Surety Company Bond No. 51949173 for Susan F. Munson as Clerk/Treasurer for the Town of Riverside in the amount of \$1,000 was approved.

Appointments

Lee Meacham moved to appoint Rowena Trapp to the Carbon County Museum Board. Linda Fleming seconded. The motion carried unanimously.

Lee Meacham moved to reappoint Dorman Ewing to the Upper Platte River Solid Waste Disposal District Board. Linda Fleming seconded. The motion carried unanimously. There is still one At-Large position open on this Board.

Lee Meacham moved to appoint Ransom Hackett to the Baggs Solid Waste Disposal District Board. Linda Fleming seconded. The motion carried unanimously.

One Percent Tax

Linda Fleming moved to put the one percent (1%) tax on the ballot in the November 2002 election. Lee Meacham seconded. The motion carried unanimously.

Prisoner Transfer Agreement

Linda Fleming moved to authorize Chairman Zeiger to sign the Agreement between Albany County and Carbon County to transport prisoners at the cost of \$60 per day per prisoner. Lee Meacham seconded. The motion carried unanimously.

ELECTED OFFICIALS

Cindy Baldwin, Treasurer, came before the Commissioners and advised that the July 2002 Capital Facilities tax distribution from the State of Wyoming was \$3,566 less than anticipated due to the State paying a refund. Consequently, each entity that received a portion of this distribution will have to pay back their proportionate share of their distribution.

County Assessor, Darrell Stubbs, brought two rebates before the Commissioners. Mr. Stubbs advised the State of Wyoming had approved their levies.

TOWN OF BAIROIL

Sue Rigano, Mayor of the Town of Bairoil, and Adene Wuertley came before the Commissioners to ask if the Commissioners would be part of a workshop with Sweetwater County, Carbon County, the Town of Bairoil, and School District #1 to discuss school boundary issues.

Chairman Zeiger called a short recess at 10:27 a.m. and reconvened at 11:30 a.m.

SPRUCE HOUSE

Shauna Chandler came before the Commissioners to discuss the development of a crisis center for children ages 11-17 in our community. Ms. Chandler would like to see a non-profit agency with a board of directors for the center.

Ms. Chandler advised an exact location had not been determined at this time, but they did like the house at 222 Spruce St. (the old bed and breakfast). She believed this location would provide more of a home-type environment than the old Kids, Inc. building.

Ms. Chandler advised that currently all youths in crisis must leave Carbon County to acquire the services that this center would provide, and it is important to keep these young people closer to home and in our County. Ms. Chandler advised it would be a non-secure facility. She asked for suggestions and input from the Commissioners.

LUNCH

Chairman Zeiger recessed the meeting for lunch at 12:05 p.m. and reconvened the meeting at 1:30 p.m.

ROAD AND BRIDGE

Bill Nation presented his bi-monthly report to the Commissioners.

Linda Fleming moved to authorize Chairman Zeiger to sign the Interest Bearing Retainage Deposit Agreement for the North Hanna Access Project between Carbon County Road & Bridge and Community First of Lander, Wyoming. Lee Meacham seconded. The motion carried unanimously.

PLANNING AND ZONING

Jay Grabow appeared before the Board to discuss a personnel issue.

Linda Fleming moved to enter into executive session to discuss personnel issues at 2:03 p.m. Lee Meacham seconded. The motion carried unanimously.

Linda Fleming moved to come out of executive session at 2:27 p.m. Lee Meacham seconded. The motion carried unanimously.

There being no further business, Chairman Zeiger adjourned the meeting at 2:30 p.m.
