NOYES CLINIC

Ron Taylor PAC and architect Mike Quinn appeared to discuss the use of the old Baggs bank building for the Noyes Clinic. A meeting was scheduled for Wednesday, April 23, 2003 at 9:00 a.m. in Baggs between the Mr. Quinn, Mr. Taylor, and Linda Fleming to further discuss the use of the building and to come up with a budget figure. Mr. Quinn agreed to have a figure and estimates when he meets with the Commissioners again at 4:00 p.m. on May 6, 2003.

Ron Taylor presented his budget request for the Noyes Clinic and the Baggs EMTs. His request for Noyes Clinic is for \$55,000.00 and the request for the EMTs is for \$4,000.00.

EXECUTIVE SESSION

A motion was made by Lee Meacham and seconded by Linda Fleming to adjourn into executive session at 10:45 a.m. to discuss personnel issues and litigation. The motion carried unanimously.

Linda Fleming moved to come out of executive session at 11:25 a.m. The motion was seconded by Lee Meacham and carried unanimously.

A motion was made by Linda Fleming that Barbara Bonds be contracted to help with the jail project financing. Lee Meacham seconded and the motion carried unanimously.

A motion was made by Lee Meacham and seconded by Linda Fleming to direct

staff to contact a firm to do an environmental impact statement in reference to the jail site. The motion carried unanimously.

LONG AND ASSOCIATES

Bill Klingsborn, Engineer, Rich Beam, Long Project Manager, and Dave Kenick of Long appeared to discuss the progression of the heating/air conditioning project. A meeting was scheduled with Linda Smith and Lee Meacham for 3:00 p.m. on April 21st, 2003 to do a "walk through" of the courthouse to discuss security and work schedule issues.

RAWLINS FIRE DEPARTMENT

Duane Stolns appeared to request that the Rawlins Fire Department be allowed to have a fireworks display on county property.

A motion was made by Linda Fleming and seconded by Art Zeiger that the City of Rawlins and the Rawlins Fire Department be allowed to use the county property opposite of the Fair Grounds for the fireworks display on July 4, 2003. The motion carried unanimously.

MINUTES

Linda Fleming moved that the April 1, 2003 minutes be approved without changes. Art Zeiger seconded the motion. The motion carried unanimously.

GAS CHOICE

Alice Garvin recommended that Carbon County make a choice to go with CIG Gas index plus a rate that is 5 cents/therm. This plan is offered by Midwest United Energy.

Lee Meacham moved that the county enter into an agreement with Midwest United Energy for one year's natural gas service, and that the same service also be offered to all county employees. Linda Fleming seconded the motion and it carried unanimously.

PLANNING AND ZONING

A motion was made by Linda Fleming that the County receive the certified action of the Carbon County Planning Commission for case files 02-23, 03-01, 03-02, 03-05, and 03-07, and hold a commission hearing for May 20, 2003 at 2:00 p.m. and ask the clerk to publicize according to law. Seconded by Commissioner Meacham. The motion carried unanimously.

ROAD AND BRIDGE

Bill Nation presented his semi-monthly report to the Commissioners.

A motion was made by Linda Fleming and seconded by Lee Meacham that the county allow \$28,527.00 from the High Savery Dam account balance be used to purchase a stockpile of road base. The motion carried unanimously.

Carbon Building

A motion was made by Lee Meacham and seconded by Linda Fleming that the contract between the County and Wyoming Department of Administration and Information - General Services Division be renewed for another year for the Department of Work Force Services to rent office space at the Carbon Building in the amount of \$14,691.40. The motion carried unanimously.
