### **Minutes**

Commissioner Meacham moved to approve the corrected minutes from the October 7, 2003 regular Commissioners meeting. The motion was seconded by Commissioner Fleming and carried unanimously.

### **Bonds**

A bond dated September 12, 2003, was approved for Jerry Johnson, Treasurer of the Carbon County Predatory Animal Board in the amount of \$5,000.00.

### **Dixon Airport Bid Opening**

There were no bids received for the bid opening for construction of an equipment storage building at the Dixon Airport.

### **Local Government Liability Pool**

Clerk Smith presented a letter from The Local Government Liability Pool (LGLP) requesting nominations for three open LGLP Board positions. The Board did not have any nominations submit.

### **County Road 648**

Commissioner Meacham moved to approve the Order Allowing Withdrawal of an Independent Hearing Officer in reference to the County Road 648 matter and that David Erickson relieve Daniel Massey as the independent hearing officer for the hearing scheduled October 28<sup>th</sup> and 29<sup>th</sup>, 2003. The motion was seconded by Commissioner Fleming and carried unanimously.

### **Monthly Receipts**

Clerk Linda Smith reported that the monthly receipts for the County Clerk's Office totaled \$18,054.75.

## **ROAD & BRIDGE**

Bill Nation presented his bi-monthly report to the Board. He also gave the Board his

recommendation that a bid for the purchase of a new pickup to be used by Road & Bridge be awarded to Fremont Motors in the amount of \$27,296.34.

Commissioner Fleming moved and Commissioner Meacham seconded to award the bid in the amount of \$27,296.34 to Fremont Motors for the purchase of a ¾ ton Ford, diesel pickup to be used by the Road & Bridge Department. The motion carried unanimously.

Commissioner Fleming moved to go into executive session for litigation and land acquisition. The motion was seconded by Commissioner Meacham and carried unanimously.
