Commissioner Fleming moved to approve the bid from Forrest Line Construction in the amount of \$120,433.00 for construction of a snow removal equipment storage building at the Dixon Airport. Chairman Zeiger seconded and the motion carried unanimously.

Commissioner Fleming moved to authorize the Chairman to sign the Request for Payment of State Funds For Airport Construction, Planning or Improvements for AIP Project No. 3-56-0038-06 for the Dixon Airport in the amount of \$240.00. Chairman Zeiger seconded and the motion carried unanimously.

Fair Board Land

Clerk Smith reported that the Fair Board has requested to move the fence line at the Fair Grounds to include an additional piece of land owned by the county. The Fair Board would like to use the land for a horse barn or a parking lot.

The Board authorized the Fair Board to use the land for one of the stated purposes.

South Central Wyoming Healthcare & Rehabilitation Easement

Clerk Smith and Land Office Clerk Sue Palato stated that Carbon County and Memorial Hospital of Carbon County are not part owners in the land that South Central Wyoming Healthcare is requesting an easement for to place a generator on. The footage was deeded from Park Manor Nursing Home to Kenneth and Lois Morgan. At that time, the Morgan's reserved a parcel of land for the parking of fifteen cars. Because of the reservations, the healthcare center should request an easement from the Morgans.

Tentative Budget for Fiscal Year 2004-2005

Clerk Smith presented the Carbon County Tentative Budget for Fiscal Year 2004-2005.

Stratton vs. Reidy

Commissioner Fleming moved to accept the Findings of Fact, Conclusions of Law and Order in regards to the Stratton vs. Reidy case, Docket No. CCR01-001. Chairman Zeiger seconded and the motion carried unanimously.

County Employee Mileage Payment

Commissioner Fleming moved to increase the payment for mileage from \$0.33 per mile to \$0.375 per mile, the same as state and federal, to begin today, May 18, 2004. Chairman Zeiger commented that he would like to change the increase to only \$0.37 per mile. Commissioner Fleming amended her motion to increase mileage to \$0.37 per mile. Chairman Zeiger seconded and the motion carried unanimously.

EMERGENCY MANAGEMENT

Greg Zabel presented his monthly report.

GIS / GPS

Karen Larsen reported on the progress of the rural addressing project. The Board asked Ms. Larsen to set a goal to complete the addressing north of Interstate 80 by July 1, 2004.

COVE

Karen Labeda, Julie Hahn, Theresa Pacheco, Teresa Sisneros and Dori Fritz of the Community Resource Center (CRC) presented a proposal for Temporary Assistance for Needy Families (TANF) Funding. The group is requesting that the County sponsor them to apply for this funding, and that the funds flow through the County, and the CRC would request the funds from the County for expenditures.

Clerk Smith requested that a Memorandum of Understanding be in place if and when the funds are awarded.

The Board agreed to sponsor the initial \$10,000.00 grant with the CRC administering it and the funding flowing through the County. The CRC will complete the grant application and return it to the Board for it's final approval.

ROAD & BRIDGE

Bill Nation presented his bi-monthly report. Mr. Nation requested authorization to make the final payments to Cat Financial for a motor-grader and a backhoe blade in the total amount of \$40,869.52. He stated that if the final payments were made now, the County would save \$4,964.72 in interest.

Commissioner Fleming moved to authorize Mr. Nation to make the final payments to Cat Financial to payoff the balances of a blade/backhoe and motorgrader in the total amount of \$40,869.52. Chairman Zeiger seconded and the motion carried unanimously.

Memorandum of Understanding - Road Asset Management

Mr. Nation presented a Memorandum of Understanding for the road asset management program. He stated that Tom Thompson has reviewed this MOU and authorized it for the Board's approval.

Commissioner Fleming moved to authorize the Chairman to sign the Memorandum of Understanding Between the University of Wyoming and Carbon County, Wyoming for a road asset management program. Chairman Zeiger seconded and the motion carried unanimously.

Seminoe Road Agreement

Mr. Nation presented a revised Seminoe Road Agreement for the Board's consideration.

Commissioner Fleming moved that the County sign the Cooperative Agreement Between the Wyoming Department of Transportation and the Carbon County Commission for Federal Project FLH-0C06-00(060) to complete Phase IV of the Seminoe Road Project. Chairman Zeiger seconded and the motion carried unanimously.

CARBON COUNTY FIRE DEPARTMENT

Dwight France updated the Board on the funding that the County would use to obtain grants for wildlife mitigation efforts on private lands.

Mr. France is requesting authorization to purchase three mobile radios, six portable radios and four pagers from Ryan Electronics. The Board questioned whether or not Homeland Security funding could be used for the purchase of the radios.

The Board authorized Mr. France to purchase the pagers and hold off purchasing the radios until June 1, 2004 when it is determined if Homeland Security funding can be used for such purchase.

RECESS

Chairman Zeiger recessed for lunch at 12:08 p.m. and reconvened at 1:46 p.m.

PUBLIC HEALTH

Bridgett Hettgar requested that the Board approve two contracts for TANF funding between the State of Wyoming and Carbon County totaling \$105,382.00.

These contracts will be presented later today for the Board's consideration.

ROCK CREEK FIRE HALL

April Sims representing the Rock Creek Country Club and T.C. Page, Rock Creek Fire Chief are requesting that a Rock Creek Jams and Jellies Club be allowed to use the kitchen at the Rock Creek Fire Hall to prepare their products. Clerk Smith stated that she has checked with the County's insurance provider who advised that non-employee individuals would not be covered under the County's liability coverage.

The Board is leaving permission of when and who may use the kitchen up to the Rock Creek Valley Fire Department. The fire department is to have each group using the building sign a Building Use and Indemnification Agreement before entering the premises, and to determine if event insurance is needed by the party renting the hall.

WIC NUTRITION PROGRAM CONTRACT

Commissioner Fleming moved to authorize the Chairman to sign the Contract for Special Supplemental Nutrition Program Between Wyoming Department of Health Women, Infants and Children and Carbon County for a term of July 1, 2004 through June 30, 2005 in the amount of \$5,195.00. Chairman Zeiger seconded and the motion carried unanimously.

WILDLAND FIRE PROTECTION PLAN

Commissioner Fleming moved to authorize Dwight France and the County Fire Department to proceed with the Community Wildland Fire Protection Plan for Seven Forested Wildland Interface Communities within Carbon County, Wyoming proposed by Land Stewardship Associates, LLC (LSA) in Denver, Colorado. Chairman Zeiger seconded and the motion carried unanimously.

TEMPORARY ASSISTANCE FOR NEEDY FAMILIES (TANF) FUNDING - PUBLIC HEALTH

Commissioner Fleming moved to authorize the Chairman to sign the two Contracts Between the State of Wyoming Department of Health, Community and Family Health Division's Maternal and Child Health (MCH) Section and Carbon County in the amounts of \$43,800.20 and \$61,581.80 and both for terms of July 1, 2004 through September 30, 2005. Chairman Zeiger seconded and the motion carried unanimously.

ADJOURNMENT

There being no further business, Chairman Zeiger adjourned the meeting at 3:20 p.m.
