Dixon Airport

Commissioner Fleming moved to authorize the Chairman to sign the Agency Agreement for Federal Aid Project No. 3-56-0038-7, State Project No. 9U4-01X dated June 7, 2004 for land acquisition at the Dixon Airport. Commissioner Meacham seconded and the motion carried unanimously.

Commissioner Fleming moved to authorize the Chairman to sign the Contract Agreement for Improvements to the Dixon Airport, Dixon, Wyoming AIP Project No. 3-56-0038-06 between Carbon County and Forest Line Construction of Sandy, UT in the amount of \$120,433.00 for construction of an equipment storage building at the Dixon Airport. Commissioner Meacham seconded and the motion carried unanimously.

Carbon County Jail and Communication Center

Clerk Smith presented a letter from Charlie VanOver of Plan One Architects

requesting a six week extension to the completion date of the new Carbon County Jail and Communication Center making the substantial completion date January 14, 2005.

JAIBG Grant

Commissioner Meacham moved to authorize the Chairman to sign the Juvenile Accountability Incentive Block Grant Contract Between State of Wyoming, Department of Family Services, Division of Juvenile Services and Carbon County to authorize an additional \$12,000.00 for the 2001 JAIBG grant. Commissioner Fleming seconded and the motion carried unanimously.

LM Olson Payment Application
