CITIZEN INPUT

Candy Moulton of Encampment presented a proposal in the amount of \$7,000.00 to research and write 14 historical signs to be mounted on County Road in Carbon County. She stated that she has discussed the proposal with Road & Bridge Superintendent Bill Nation. The Board will take her proposal under consideration.

CLERK

Minutes

Commissioner Weickum moved to approve the minutes from the February 1, 2005 Commissioners meeting as presented. Chairman Zeiger seconded and the motion carried unanimously.

Bonds

Commissioner Weickum moved to approve a bond for Rusena Cobb, Treasurer for the Little Snake River Museum District of Savery in the amount of \$2,000. Chairman Zeiger seconded and the motion carried unanimously.

Monthly Receipts

Chief Deputy Obe presented monthly receipts for Planning & Zoning in the amount of \$460.00.

LM Olson Payment Application

Commissioner Weickum moved to accept LM Olson's Payment Application No. 19 in the total amount of \$113,340.00 with \$102,006.00 being paid to LM Olson and \$11,334.00 being paid to LM Olson's escrow account and authorized the application be forwarded to the Carbon County Detention Facility Joint Powers Board for payment. Chairman Zeiger seconded and the motion carried unanimously.

Dixon Airport

Commissioner Weickum moved to authorize the Chairman to sign the Certificate of State Grant-In-Aid for State Project 9U4-01X and State Grant No. 2343, amending the legal description of the original Certificate for the Dixon Airport. Chairman Zeiger seconded and the motion carried unanimously.

Cooperative Extension Service

Chief Deputy Obe presented a letter from the Cooperative Extension Service requesting one Commissioner serve on a committee to assist in the selection of a new 4-H Director. Commissioner Weickum volunteered to serve on the committee.

PLANNING & ZONING CONCERNS

Shorty Ballard discussed concerns of the Carbon County Land Use Plan and the 640-acre rule. Mr. Ballard questioned why Carbon County has a 640-acre rule.

William Speer of the Planning Commission replied that the 640-acre rule only limits how the land will be used and not the division of the property.

Chairman Zeiger and Commissioner Weickum scheduled a workshop with the Planning Commission and the Board of County Commissioners to be held at 3:00 p.m. on February 25, 2005 at the County Courthouse to discuss the 640-acre rule.

COALBED METHANE COALITION

Mickey Steward of the Coalbed Methane Coalition overviewed the draft comments for the Environmental Impact Statement (EIS) for the Rawlins Resource Management Plan (RMP). Ms. Steward stated that the EIS discloses the potential effects of the implementing the RMP. She presented a draft summary of what the Coalition feels are the eight most critically important comments. She asked the Board to review these comments and report back to her with any changes or additions.

ROAD & BRIDGE

Bill Nation overviewed the main areas and County Roads that coalbed methane development is affecting.

Mr. Nation presented his bi-monthly report. He stated his support for Candy Moulton's proposal to install historical signs on County Roads. He will formally introduce a proposal at a future meeting.

ADJOURNMENT

There being no further business, Chairman Zeiger adjourned the meeting at 8:58 p.m.
