### **CLERK**

All minutes from the previous meetings in November (11/03/98 & 11/17/98), December (12/01/98 & 12/15/98) and January 5, 1999 were approved.

### **PUBLIC INPUT**

Scott Kerbs advised the Commissioners of a countywide effort to establish an advisory group for a county wildlife group. A motion was made by Linda Fleming, seconded by Lee Meacham and unanimously carried to take the endorsement of the county wildlife advisory group under advisement.

### **PLANNING**

Jonathan Schnal updated the Commissioners on an easement relating to the Ralph and Pat Zordel/Larry Barrailler property regarding the stock drive.

A motion was made by Lee Meacham, seconded by Linda Fleming and unanimously carried to direct the County Attorney to draft a quit claim deed. This deed will convey to Ralph and Pat Zordel and Larry Barrailler the County's interest in the Walcott to Saratoga stock drive as it sits on the Zordel/Barrailler property (10 acres) in exchange for and conditioned upon receipt of a 30' wide roadway right of way along the eastern boundary of the Zordel/Barrailler property.

Jonathan Schnal advised the Commissioners that a public hearing would be held at the next regular meeting. Approval for the zone change will be presented at that time.

Jonathan Schnal requested permission to apply for a grant. He will report back to the Commissioners with more information at the next regular meeting.

### **ROAD & BRIDGE**

Bill Nation and Paul McCarthy reported on the Seminoe Road project north of the dugway. They are mapping in the north section and proceeding with culverts and drainage.

Mr. Nation gave an administrative report.

**JEFFREY CENTER PARKING LOT**

A letter signed by Ara Erickson, Jeffrey Center Board Chairman was presented to the Commissioners. The other commissioners appointed Lee Meacham to check into this matter further. Linda Ann Smith, Carbon County Clerk will write a letter acknowledging receipt of this letter and will schedule the matter for discussion. This matter was taken under advisement until the next regular meeting.

**FIRE DEPARTMENT**

The Commissioners discussed the proposed McFadden fire building and asked the County Clerk to research the impact money from the wind farms for payment of this project.
