A special meeting of the Board of Carbon County Commissioners (BOCC) commenced Wednesday, September 3, 2014. Attending the meeting were; Chairman Leo Chapman; Vice Chairman John Espy; Commissioners Lindy Glode, Sue Jones and John Johnson.

Chairman Chapman called the meeting to order at 8:00 a.m. at the County Courthouse in Rawlins, Wyoming.

**HEALTH INSURANCE**

Commissioner Johnson moved to use Delta Dental WY for the county's dental plan effective October 1, 2014. Commissioner Jones seconded and the motion carried unanimously.

Commissioner Jones moved to use VSP Choice Plan for vision effective October 1, 2014 and grandfather the Lasix benefit at the level individuals are currently eligible for one year. Commissioner Glode seconded and the motion carried unanimously.

Commissioner Glode moved to have a high and low plan with Blue Cross Blue Shield effective January 1, 2015 outlined as follows: a plan with a \$500.00 single or \$1,000.00 family deductible, coinsurance of 20% out of network or 10% in network and a maximum out of pocket of \$2,500.00 single or \$5,000.00 family for premiums of \$200.00 single, \$400.00 single + child, \$440.00 employee + spouse and \$500.00 family or a plan with a \$1,000.00 single or \$2,000.00 family deductible, coinsurance of 30% out of network or 20% in network and a maximum out of pocket of \$3,500.00 single or \$7,000.00 family for a premium of \$100.00 single, \$200.00 single + child, \$220.00 employee + spouse and \$250.00 family. Commissioner Johnson seconded and the motion carried unanimously.

**ADJOURNMENT**

Commissioner Johnson moved to adjourn the meeting at 10:43 a.m. Commissioner Espy seconded and the motion carried unanimously.
