CARBON COUNTY SENIOR SERVICES, INC.

John Peery, Executive Director of Carbon County Senior Services, Inc. presented a budget request in the amount of \$111,929.00 for fiscal year 1998-99. The request was taken under advisement.

SHERIFF

Sheriff Jerry Colson presented a law enforcement agreement for the Board's consideration. The agreement between Carbon County and the Bureau of Land Management would reimburse Carbon County for providing law enforcement on public lands and roads administered by the Bureau of Land Management in Carbon County through September 30, 1998.

A motion was made by Fleming, seconded by Graalman, and unanimously carried to enter into the agreement with the Bureau of Land Management.

PLANNING

Carbon County Planning Commission member, Henry Hewitt and County Planner, Johnathan Schnal updated the Board on the printing and distribution of the revised land use plan.

A motion was made by Fleming, seconded by Graalman, and unanimously carried to set the hearing date for the land use plan for 7:00 p.m., June 2, 1998 at the Jeffrey Center.

ECONOMIC DEVELOPMENT

Carbon County Economic Development, Inc. (EDC) director, Johnathan Schnal obtained the Board's signature confirming the hearing held April 7, 1998 for the EDC's community development block grant application to the State of Wyoming.

OLSON ROAD ISSUE

A motion was made by Graalman, seconded by Fleming and unanimously carried to appoint Wade Waldrip hearing officer in the matter of the Application of L.M. Olson, Inc., Applicant for a private road.

Fred Hansen, representing L.M. Olson, Inc., presented a map and indicated the area involved in the private road application.

EXECUTIVE SESSION

A motion was made by Fleming, seconded by Graalman, and carried to enter into Executive Session to discuss litigation (7:45 p.m.).

A motion was made by Fleming, seconded by Graalman, and carried to come out of Executive Session.

PREDATORY ANIMAL CONTROL BOARD

John Strand and Gary Vivion, representing the Carbon County Predatory Animal Control Board

presented a budget request of \$10,000 for fiscal year 1998-99. The request was taken under advisement.

Merril Nelson, contract trapper, Strand and Vivion discussed the predatory animal control program and its future plans for Carbon County.

ROAD & BRIDGE

Bill Nation, Carbon County Road & Bridge supervisor presented his semi-monthly report on road work throughout the county and general administration of the Road & Bridge department.

FIRE DEPARTMENT

A motion was made by Fleming, seconded by Graalman, and carried to enter into an interagency cooperative fire protection agreement with the Bureau of Land Management, Wyoming State Forestry Division, and USDA Forest Service through April 15, 1999.
