#### **FINANCIAL REPORT**

A monthly financial report from the County Clerk's office was approved by the Board.

#### **WATER STUDY**

Various federal and state representatives associated with the Colorado, Wyoming, Nebraska environmental impact study to establish wetlands in Nebraska for endangered birds, discussed the progress of their study and explained how the study process works. The Commissioners stated that they wanted Carbon County representation on every study committee possible. The federal and state representatives acknowledged the request and suggested various avenues of participation. Zeiger announced that Kurt Bucholz will represent Carbon County's interest regarding this water issue.

#### **DELINE ROAD ISSUE**

County Attorney Tom Campbell gave an update on the Deline road issue.

#### **RUSSELL BUILDING PERMIT**

No representative appeared for Jack Russell to discuss his appeal of the Planning Commission's denial of a building permit in the Separation Flats area of Carbon County. No further information will be exchanged regarding this appeal, and the Commissioner's will make a decision on the appeal within thirty days.

## **PLANNING**

Henry Hewitt of the Planning Commission, introduced the new County Planner, Jonathan Schnol. Hewitt also offered staff assistance for Kurt Bucholz, water representative for Carbon County.

### **NORTH HANNA ACCESS ROAD PROJECT**

Jim Larscheid of PMPC Consulting Engineers presented answering correspondence from Carbon County Government to the Wyoming Department of Environmental Quality regarding the North Hanna Access Road Project grant application.

### **SARATOGA-ENCAMPMENT-RAWLINS CONSERVATION DISTRICT**

Glen Leavengood of the Saratoga-Encampment-Rawlins Conservation District requested consideration of a proposed resolution taken under advisement at the March 3, 1998 commissioner meeting.

A motion was made by Graalman, seconded by Fleming, and unanimously carried to approve the following:

#### **RESOLUTION 1998 - 2**

#### **RESOLUTION SUPPORTING MEDICINE BOW CONSERVATION DISTRICT, SARATOGA-ENCAMPMENT-RAWLINS CONSERVATION DISTRICT, AND LITTLE SNAKE RIVER CONSERVATION DISTRICT ALONG WITH THEIR CO-APPLICANTS IN THEIR APPLICATION FOR A 205j GRANT FROM THE WYOMING DEPARTMENT OF ENVIRONMENTAL QUALITY FOR THE DEVELOPMENT OF CREDIBLE TMDL BASELINE DATA WATER BODIES OF THE 303(d) IMPAIRED LIST**

**Whereas**, the legislation in Section 303(d) of the Clean Water Act requires each state to list all waters which do not support existing or designated beneficial uses;

**Whereas**, the Wyoming Department of Environmental Quality is the designated state agency to administer this legislation;

**Whereas**, the assessment process for evaluation and improvement of the affected state's water bodies is known as Total Maximum Daily Load (TMDL);

**Whereas**, the Medicine Bow River and two (2) segments of the North Platte River has been listed by WY-DEQ as an impaired stream on the 1998 listing of the thirty (30) high priority streams;

**Whereas**, another fourteen (14) streams\* have been listed by WY-DEQ as "needs monitored" water bodies;

**Whereas**, the water quality of these water bodies may or may not be dependent upon many non-point source contributions;

**Whereas**, the Medicine Bow Conservation District, Saratoga-Encampment-Rawlins Conservation District, and Little Snake River Conservation District will coordinate water quality data collection to be used in establishing credible data for baseline conditions;

**Now therefore, be it resolved** by the County Commissioners of Carbon County, Wyoming:

That the Carbon County Commissioners will support the 205j grant application of the Medicine Bow Conservation District, Saratoga-Encampment-Rawlins Conservation District, and Little Snake River Conservation District along with their co-applicants for funding to develop:

- 1) a work plan to obtain standardized, credible data on the above mentioned water
- 2) baseline data for these stream segments and
- 3) a local planning effort to voluntarily improve water quality on water bodies deemed to be not fully supporting of their beneficial uses.
