Carbon Building Manager, Patricia Schuler met with the Board to discuss office space lease renewals for the various Wyoming state agencies housed in the Carbon Building.

#### **SENIOR CENTERS**

John Peery of Carbon County Senior Services, Inc. reported on meal counts and repairs needed at the various senior center locations throughout Carbon County. Also discussed was senior transportation services provided by Carbon County Senior Services, Inc.

#### **CO-OP EXTENSION SERVICE**

County extension agents, Doug Reynolds and Ruth Wilson, appeared before the board to discuss the vacant 4-H agent position.

#### **NORTH HANNA ACCESS ROAD PROJECT**

Jim Larscheid of PM PC Consulting Engineers reported on the general progress of the North Hanna access road project and specifically the AML draft application for funding.

#### **DELINE ROAD**

John MacPherson and Kermit Brown, attorneys representing parties having an interest in the Deline Road issue, met with the Commissioners to discuss the progress of the road request.

A motion was made by Fleming, seconded by Graalman and unanimously carried to instruct County Attorney Tom Campbell to set a hearing date to address the road application.

#### **PLANNING**

Henry Hewitt, representing the Carbon County Planning Commission, and Planning Director Jim Pedersen presented an administrative report.

**SARATOGA-ENCAMPMENT-RAWLINS CONSERVATION DISTRICT**

Glen Leavengood, representing Saratoga-Encampment-Rawlins Conservation District, and Tom Barnes, representing Medicine Bow Conservation District presented a resolution for Commissioner consideration. The resolution gives county support to the Carbon County conservation districts' application for a 205J grant from the Wyoming Department of Environmental Quality for the development of credible data for baseline water standards. The request was taken under advisement.

**PUBLIC HEALTH**

A motion was made by Fleming, seconded by Graalman and unanimously carried to execute a contract between the State of Wyoming, Department of Health and Carbon County Public Health Nursing Services for the period of July 1, 1998 through June 30, 2000. The County will assist the state in determining medical eligibility and pre-admission review for Medicaid recipients in Carbon County.

**JACK RUSSELL BUILDING PERMIT**

At 3:00 p.m. appointment on the Commissioner's agenda was made to hear Jack Russell's appeal to the Planning Commission denial of his application for building permit in the Separation Flats area approximately 18 miles north of Rawlins in Carbon County. Russell nor any representative of his appeared to discuss the appeal. Russell's written appeal was taken under advisement until the March 17, 1998 Commissioner meeting.

**EVERGREEN DISPOSAL**

Sam Lawson of Evergreen Disposal appeared before the Commissioners to request an opportunity to bid on trash removal services at various Rawlins locations owned by Carbon County Government. The request was taken under advisement.

Carbon County Road & Bridge supervisor, Bill Nation presented his administrative report.
