**PUBLIC HEARING**

Bill Saulcy and Jim Patterson were in attendance to present the venture capital program in Carbon County.

A Public Hearing was held on behalf of a \$15,000 Economic Development "planning only" grant application prepared by the Carbon County Economic Development Corporation (CCEDC) for the 1997 Community Development Block Grant (CDBG) program administered by the Wyoming Department of Commerce. The grant application is for feasibility research of a Carbon County small business venture capital program from the Commerce Department \$70,000 "planning only" program category.

**RESOLUTION**

A motion was made by Gary Graalman, seconded by Linda Fleming and unanimously carried to adopt the following resolution:

**RESOLUTION 1997 - 12**

**WHEREAS**, the Carbon County Economic Development Corporation (CCEDC) exists to encourage the retention expansion of existing industries and businesses and promote the attraction of new economic investment in Carbon County, Wyoming, and;

**WHEREAS**, the CCEDC has solicited a grant award of \$15,000.00 from 1997 Community Development Block Grant program administered by the State of Wyoming, Department of Commerce, for the purpose of conducting a feasibility study that evaluates the potential formation of a venture capital program in Carbon County, and;

**WHEREAS**, it is the finding of the Commission that such a venture capital program, if feasible, could help promote and provide needed investment capital to assist in the establishment or expansion of small businesses and enterprises, thus potentially adding diversity and stability to the regional economy, and;

**WHEREAS**, it is the finding of the Commission that the CCEDC has complied with all the requirements of the CDBG programs application progress, including both the publication of a Public Notice on October 14th, 1997, and the conducting of a public hearing before this Commission on October 21st, 1997, and therefore;

**IT IS HEREBY RESOLVED** that the Carbon County Board of Commissioners endorses the CCEDC's application to the Wyoming Department of Commerce for a \$15,000.00 Community Development Block Grant to support the preparation of a venture capital program feasibility study.
