GOVERNOR'S SUMMIT - Karen Larsen

Karen Larsen updated the Commissioners on the Governor's Summit for Wyoming's future. The Commissioners directed Karen Larsen and Connie Jordan to draft an action plan for this project.

ROAD & BRIDGE

Bill Nation gave his administrative report.

A motion was made by Linda Fleming, seconded by Gary Graalman and unanimously approved to write a letter of support for the request and resolution adopted by the Board of Viewers for Alternate 1 of 1.3 miles of road for the North Hanna Access. The Board of Carbon County Commissioners authorized the submittal of the information and application of the North Hanna Access Road to the Wyoming Department of Transportation for funding through the Industrial Roads Program.

The Commissioners signed an Acceptance Certificate for Project SC-CFM 6-53, County Roads #215, #400, and #404 and also an Acceptance Certificate for Project SC-CFM 6-55, County Roads #205, #209, #324, and #504.

The Commissioners signed a copy of the Reconnaissance Report for the second phase of the Seminoe Dam Road, County Road #351, Project SC-CFM 6-54.

QUITCLAIM DEED

A motion was made by Linda Fleming, seconded by Gary Graalman and unanimously approved to sign a Quitclaim Deed from Carbon County to Janice K. Fiedor for the following described property:
