**A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS,

STATEMENT OF INVESTMENT POLICY**

**WHEREAS**, Wyoming Statute Section 9-4-831 (h) requires every political subdivision of the State of Wyoming to adopt a **Statement of Investment Policy**.

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS, CARBON COUNTY, WYOMING**, that it does hereby adopt the **Statement of Investment Policy**, attached as Exhibit A and incorporated herein by this reference, and does declare it in effect on July 1, 1996.
