MEMORIAL HOSPITAL OF CARBON COUNTY

A motion was made by Gary Graalman, seconded by Linda Fleming and unanimously carried to accept the following resolution:

A RESOLUTION AUTHORIZING SUBMISSION OF A FEDERAL MINERAL ROYALTY CAPITAL CONSTRUCTION ACCOUNT GRANT APPLICATION TO THE FARM LOAN BOARD ON BEHALF OF THE GOVERNING BODY FOR THE BOARD OF COUNTY COMMISSIONERS, CARBON COUNTY, WYOMING FOR THE PURPOSE OF CONSTRUCTION OF A CLINIC AND NEW EMERGENCY ROOM FOR MEMORIAL HOSPITAL OF CARBON COUNTY,

WITNESSETH

WHEREAS, the Governing Body for Carbon County, Wyoming desires to participate in the FEDERAL MINERAL ROYALTY CAPITAL CONSTRUCTION ACCOUNT GRANT program to assist in financing this project; and

WHEREAS, the Governing Body of the Carbon County, Wyoming recognizes the need for the project; and

WHEREAS, the Federal Mineral Royalty Capital Construction Account Grant program requires **that certain criteria be met, as described in the Farm Loan Board's Rules and Regulations governing the program**, and to the best of our knowledge this application meets those criteria; and

WHEREAS, the Governing Body of Carbon County, Wyoming plans to match requested Federal Mineral Royalty Capital Construction Account grant from the following source (s):

\$ 750,000 - Grant Farm Loan Board
\$ 250,000 - Memorial Hospital of Carbon County, Wyoming
\$1,500,000 - Loan Department of Agriculture, Rural Development

NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE COUNTY OF CARBON, STATE OF WYOMING, that a grant request in the amount of \$750,000 be submitted to the Farm Loan Board for consideration at the January 1997 grant meeting to assist in funding an Outpatient clinic and Emergency Room for Memorial Hospital of Carbon County, Wyoming.

BE IT FURTHER RESOLVED, that Richard Johnson, CEO, Memorial Hospital, and Linda Smith, Board Member, Carbon County, Memorial Hospital, are hereby designated as the authorized representatives of Memorial Hospital to act on behalf of the Governing Body of Carbon County, Wyoming on all matters relating to this grant application.
