A hearing was held at 10:00 a.m. to amend the Carbon County Library budget for fiscal year 1995-96. A motion was made by Fleming, seconded by Graalman and carried to approve and adopt the following:

R E S O L U T I O N    1 9 9 6 - 2

A RESOLUTION AUTHORIZING AMENDMENT OF THE CARBON  
COUNTY, WYOMING BUDGET FISCAL YEAR 1995-96

WHEREAS, the Carbon County Library has received \$45,920.00 additional revenue from grants and gifts to be used within the 1995-96 budget year ending June 30, 1996.

WHEREAS, notice was published on April 23, 30 and May 7, 1996 in the Rawlins Daily Times of the public hearing to amend the Carbon County Library budget as required by statute.

WHEREAS, the public hearing was held May 7, 1996 at 10 a.m. in the Commissioners Meeting Room of the Carbon County Courthouse, Rawlins, Wyoming to hear protests regarding the proposed amendment. There were no protests received during the public hearing regarding said proposed amendment.

NOW, THEREFORE, IT IS HEREBY RESOLVED, that the Carbon County Library budget for fiscal year 1995-96 be increased by \$45,920.00 for additional funds received.

CARBON COUNTY LEASE

The Commissioners signed a lease with the State of Wyoming, whereby the state will lease from the county 8,921 square feet of office space in the county owned Carbon Building located at 215 West Buffalo.

SANDSTONE WATER PROJECT

Pat O'Toole and Larry Hicks presented a letter prepared by the Little Snake River Conservancy District and local Ad Hoc committee for water development in the Little Snake River Valley. The letter to Michael Purcell, Director of the Wyoming Water Development Office addressed flawed hydrologic data regarding the feasibility of the proposed Dutch Joe dam site and Chapter I comments & general concerns with the draft E.I.S. for the Sandstone project.

LIBRARY

Citizen John Bertl of Rawlins expressed his concern regarding the library card application process.

PLANNING

Henry Hewitt and Sandy Pederson, representing the County Planning office gave a monthly report and discussed various planning related topics with the Commissioners. No action was taken.

FIRE PROTECTION

Dwight France and Rob O'Connell of the County Fire Department met with the Commissioners to report on the Ryan Park Fire Station project, the strike team, and mutual aid agreements.

A motion was made by Graalman, seconded by Fleming and carried to enter into an agreement with the City of Rawlins, Town of Sinclair, and the Bureau of Land Management to provide assistance or mutual aid in fire protection within Carbon County. A copy of the agreement is on file in the office of the County Clerk.

ROAD & BRIDGE G.I.S.

Robert King of Sunrise Engineering presented a program on geographic information systems (G.I.S.).

RYAN PARK WATER & SEWER DISTRICT

Robert Westerfield representing the Ryan Park Water & Sewer District, met with the Commissioners to discuss the district's mill levy request.

CARBON COUNTY COALITION

Ruth Shepard and Bill Ellis, representing the Carbon County Coalition, reported on the activities of the coalition and requested from the Commissioners a date to schedule a public meeting in Baggs with the Wyoming Game & Fish and U.S. Wildlife Service. The meeting was set for July 12, 1996 at 7:00 p.m.

ROAD & BRIDGE

Supervisor Don Neuman, reported on the activities of the County Road & Bridge Department.
