Linda Fleming made a motion to sign the following five (5) agreements:

- 1) Agreement for Professional/Consultant Services between Carbon County Public Health Nursing Service and Park Manor Nursing and Convalescent Home.
- 2) Agreement for Professional/PreNatal Instructor Services between Carbon County Public Health Nursing Service and Tamara Lundberg MSP, FNP.

- 3) Agreement for Professional/Consultant Services between Carbon County .Public Health Nursing and Community Care at Saratoga .
- 4) Medical Eligibility and Preadmission Review .Contract agreement between the State of Wyoming, Department of Health, Division of Health Care Financing and Carbon County Public Health.
- 5) A contract with Kim Peterson MSW, CSW and Carbon County Public Health Department to provide medical social worker services.

#### LIQUOR LICENSE HEARING

Gary Graalman made a motion and seconded by Linda Fleming to approve the transfer from Daniel Davidson to Whistle Pig Inc., a highway business located in the W½, NW¼ of Section 24, Township 17 North, Range 84 West of the 6th P.M. in Carbon County, Wyoming. This motion was unanimously approved.

#### SENIOR SERVICES

Buddy Rae updated the Commissioners on the Federal Funds Reduction and also on the breakdown of total meals.

#### SARATOGA-ENCAMPMENT-RAWLINS CONSERVATION DISTRICT

Jim Wiant, Dan Mika and Scott Kerbs presented a petition to the Carbon County Commissioners proposing a Conservation District Tax. The Commissioners took this request under advisement.

#### CARBON COUNTY COUNSELING CENTER

The Commissioners signed a letter of support for the Carbon County Counseling Center in providing mental health and substance abuse services to the citizens of Carbon County.

#### PLANNING

Jim Pedersen presented Public Hearing Case File #96-01 requesting a zone change. The petitioners are Robert and Patricia Haigh. The property is situated along the southeast side of Cow Creek Road #106, about seven miles northwest of Encampment. The legal description is 7.23 acres of NW¼NE¼; Section 31, T16N,R83W. They are requesting rezoning from Ranch-Agriculture-Mining (RAM) to Residential (RD). Linda Fleming made a motion, seconded by Gary Graalman and unanimously approved to grant the zone change from RAM to RD-7.

#### OLD PENITENTIARY JOINT POWERS BOARD

Linda Fleming made a motion to appoint Monte M. Thayer to the Old Penitentiary Joint Powers Board to fill the unexpired term of Ed Walker whose term expires on May 1998. This motion was seconded by Gary Graalman and unanimously approved.

The County Commissioners signed a Proclamation declaring the week of April 21 to April 27, 1996 to be Rawlins Carbon County, Wyoming Crime Victims' Rights Week.

#### ROAD & BRIDGE

The Commissioners received a letter from the Wyoming Department of Transportation granting permission to remove material from the North Rawlins Quarry north of Rawlins. North Rawlins Quarry, Portions of Section 31 T22N,R87W .

A letter was writted by the County Commissioners to Andy Long III, P.E. of the Wyoming Department of Transportation of Rawlins informing him that Carbon County has received permission to access the Wyoming Department of Transportations North Rawlins Quarry to remove an estimated amount of 4,200 cubic yards of reject material at a price of \$0.585 per cubic yard.
