County Road & Bridge Supervisor, Don Neuman gave his administrator's report.

#### SALARY RESOLUTION

A motion was made by Graalman, seconded by Fleming and carried with the following roll call vote: Zeiger, aye; Graalman, no; Fleming aye, to approve the salary resolution as follows:

### R E S O L U T I O N            1 9 9 4 - 5

WHEREAS, the Board of County Commissioners of Carbon County, Wyoming are lawfully assembled in a regular meeting of said board in the Courthouse Building, Rawlins, Wyoming;

WHEREAS, Section 18-3-107, Wyoming Statutes, 1977, provides that the Board of County Commissioners of each county in the State of Wyoming shall meet not later than June first of the year preceding any election for County Assessor, County Prosecuting Attorney, County Clerk, Clerk of the District Court, County Sheriff and County Treasurer; and

WHEREAS, said Section 18-3-107, Wyoming Statutes, 1977, also provides that each County Commissioner will be paid such compensation as the Board of County Commissioners determine by resolution, and that said board shall meet not later than June 1, 1994, for the purpose of setting their salaries for the following four years, commencing January 2, 1995; and

WHEREAS, the board has determined that the County Attorney, County Sheriff, County Assessor, County Clerk, Clerk of the District Court, and County Treasurer shall receive an annual salary for the calendar year 1995 in the amount of 40,500.00, and an annual salary for the calendar year 1996 for \$41,000.00, and an annual salary of \$41,500.00 for the calendar year 1997, and an annual salary of \$42,000.00 for the calendar year 1998, together with the same benefits as accorded other county employees; and

WHEREAS, the Board of County Commissioners has further determined that the County Coroner whose term shall commence on January 2, 1995, shall be paid an annual salary in an amount of \$14,900.00 for the calendar year 1995, an annual salary in an amount of \$15,400.00 for the calendar year 1996, and an annual salary in an amount \$15,900.00 for the calendar year 1997, and an annual salary of \$16,400.00 for the calendar year 1998; and

WHEREAS, the Board of Commissioners has further determined that each County Commissioner on January 2, 1995 shall be paid an annual salary in an amount of \$14,400.00 in each of the calendar years cif 1995 through 1998; and

NOW, THEREFORE, BE IT RESOLVED that the County Assessor, County Clerk, Clerk of the District Court, County Sheriff, County Attorney and County Treasurer of Carbon County, Wyoming, shall receive annual salary of. \$40,500.00 for the calendar year 1995, \$41,000.00 for the calendar year 1996, \$41,500.00 for the calendar year 1997, and \$42,000.00 for the calendar year 1998. In addition to said monetary compensation, the said elected officers of Carbon County, Wyoming, shall receive the same benefits as accorded other employees of Carbon County, Wyoming, at the date of the adoption of this resolution, including but not limited to the same retirement matching contributions from the county as other county employees, and the same coverage under any county insurance policies at the rates accorded other county employees.

BE IT FURTHER RESOLVED, that the Coroner, with an effective term commencing January 2, 1995 shall be compensated in the amount of \$14,900.00 for the calendar year 1995, in the amount

of \$15,400.00 for the calendar year 1996, in the amount of \$15,900.00 for the calendar year 1997, and in the amount of \$16,400.00 for the calendar year 1998. In addition to said monetary compensation, the said elected officers of carbon County, Wyoming, shall receive the same benefits as accorded others of Carbon County, Wyoming, at the date of the adoption of this resolution, including but not limited to the same retirement matching contributions from the county as other county employees, and the same coverage under any county insurance policies at the rates accorded other county employees.

BE IT FURTHER RESOLVED, that each of the County Commissioners, commencing January 2, 1995, shall be compensated in the amount of \$14,400.00 annually. In addition to said monetary compensation, the said elected officers of Carbon County, Wyoming, shall receive the same benefits as accorded other employees of Carbon County, Wyoming, at the date of this resolution, including but not limited to the same retirement matching contributions from the county as other county employees, and the same coverage under any county insurance policies at the rates accorded other employees.

BE IT FURTHER RESOLVED, that the salaries herein established shall not be changed during the four year term of said elective officers.

BE IT FURTHER RESOLVED, that this shall have an effective date of the 17th day of May, 1994.
