Mark Setright, representing the Old Pen, updated the Commissioners on the current projects at the Old Pen, and notified the Commissioners that Ranson E. Baker will not be able to be reappointed to the Old Pen Board.

#### SHERIFF

County Sheriff, Chet Engstrom submitted two bids for a new truck. The bids are as follows:

A motion was made by Fleming, seconded by Graalman and unanimously carried to accept the McGee-Murphy, Inc. bid with a 30 to 45 day pay off period.

#### CARBON COUNTY SENIOR SERVICES, INC.

Kathy Matson, Ramona Houseman and Jim Mahon, representing Carbon County Senior Services, Inc. presented their budget request for fiscal year 1994-95.

The Commissioners signed a letter of support for the Carbon County Senior Services, Inc. program. The letter was addressed to Morris Gardner of the Division on Aging in Cheyenne. Also signed was a letter of support for the Senior Services Adult Home Care Program.

#### MOUNTAIN BIKES

A BLM mountain bike video was shown by Ray Hansen of BLM. Hansen also updated the Commissioners on the Rawlins Mountain Bike Club and their projects.

#### GREAT DIVIDE SOLID WASTE DISTRICT

Dan Aneiros of the Great Divide Solid Waste District updated the Commissioners on the progress of the district.

#### C.O.V.E.

A motion was made by Graalman, seconded by Fleming and unanimously carried to designate the week of April 24th through 30th, 1994 as County Victim's Rights Week.

#### PUBLIC HEALTH

Sue Smith, representing the Carbon County Public Health office, requested \$1,863.16 to purchase new equipment. The Commissioners approved \$500.00 to purchase new equipment.

#### A.D.A.

Irene Archibald discussed the progress of the A.D.A. assessment for Carbon County Government.

#### CARBON BUILDING

A motion was made by Graalman, seconded by Fleming and unanimously carried to enter into an agreement for maintenance with Johnson Controls for the Carbon Building.

#### CO-OP FIRE CONTROL

The Commissioners signed an agreement with the Bureau of Land Management, U. S, Forest Service, and Wyoming State Forestry Division for wildland fire control.

ROAD & BRIDGE

Don Neuman and Bart Evans of the County Road & Bridge Department, presented the administrative report for that department.

The Commissioners agreed to supply some equipment to improve the Rim Lake Road and agreed to allow county employees to operate the county's equipment during their time off from the county as contract labor for the BLM.

CARBON COUNTY CHILD DEVELOPMENT PROGRAH

The Commissioners wrote a letter supporting the efforts of Director Sharon Cooper and the administrative board of Carbon County Child Development in obtaining funds from the Division of Developmental Disabilities.

LAND USE PLAN

The Commissioners wrote a letter to Jerry Schmidt, Supervisor of the Medicine Bow National Forest in Laramie informing him that Carbon County is not prepared to submit a comprehensive county land use plan by the deadline date of May 5, 1994.

QUIT CLAIM DEED

A motion was made by Fleming, seconded by Graalman and unanimously carried to execute a quit claim deed to the City of Rawlins for the following described property:
