County Road & Bridge Supervisor, Don Neuman gave his administrator's report.

BAGGS SENIOR CENTER

A motion was made by Fleming, seconded by Graalman and unanimously carried to install an Ansul hood fire system at the Baggs Senior Center.

SIERRA MADRE WATER AND SEWER JOINT POWERS BOARD

The Commissioners granted an easement to the Sierra Madre Water and Sewer Joint Powers Board for water and sewer lines to cross county land in the town of Riverside.

SEMINOE DAM ROAD

The Commissioners signed a memorandum of agreement with the Federal Highway Administration, Bureau of Land Management, Wyoming State Historic Preservation Office, Advisory Council on Historic Preservation, and Wyoming Transportation Department regarding historic properties affected by reconstruction of a segment of the Seminole Dam Road.
