#### CHILD SUPPORT ENFORCEMENT

#### PLANNING

A public hearing was held for zone changes.

A motion was made by Graalman, seconded by Fleming and unanimously carried to take the following zone change under advisement and to make a decision at the Commissioners meeting to be held on October 19, 1993:

Case File #93-05 - Zone Change - Daniel Davidson, P.O. Bo 1288, Saratoga, WY 82331. A Zone Change from RAM (Ranching, Agriculture, Mining) to HB Highway Business) to allow for development of a commercial business on approximately 25 acres legally described as the west 500 feet lying east of Highway 130 in the SW\NW\NW\ and the SW\NW\ Section 24, Township 17 North, Range 84 West, Carbon County, Wyoming.

A motion was made by Graalman, seconded by Fleming, and unanimously carried to take the following zone change under advisement:

Case File #93-10 - Burns Brothers Truck Stop, P.O. Box 373, Sinclair, WY 82334. A Zone Change from RAM (Ranching, Agriculture, Mining) to HB Highway Business) to allow for new signs to be erected at the truck stop on land legally described as in the NE\SE\ of Section 22, Township 21 North, Range 86 West, Carbon County, Wyoming.

#### LAW ENFORCEMENT

A motion was made by Fleming, seconded by Graalman and unanimously carried to enter into an intergovernmental agreement for reciprocal law enforcement with Routt County, Colorado.

#### COMMUNITY SERVICE BLOCK GRANT

A motion was made by Fleming, seconded by Graalman and unanimously carried to enter into a contract with the Wyoming Department of Health for a community service block grant. The grant in the amount of \$40,491.00 will cover medical assistance for low-income people, parenting education for low-income families and family planning assistance for low-income families.
