Cindy Baldwin, representing the Treasurer's office updated the Commissioners on a meeting to be held in September for the purpose of planning legislation.

PUBLIC HEARING - COMMUNITY BLOCK GRANT

A public hearing was held at 10:00 a.m. to receive requests for the proposed use of Community Block Grant Funds.

Genny Lewallan, representing Carbon County Public Health requested \$10,491.00 toward parenting classes and \$30,000.00 toward emergency medical programs.

A motion was made by Fleming, seconded by Graalman and unanimously carried to approve \$36,491.00 for Public Health's request.

Dave Fanke, representing Western Wyoming Family Planning requested \$4,000.00 to be used for a medical testing program.

A motion was made by Graalman, seconded by Fleming and unanimously carried to approve \$4,000.00 for Western Wyoming Family Planning's request.

Irene Archibald, an independent risk management consultant, asked for the Commissioner's support in obtaining grant monies for A.D.A. compliance of the County owned elevators.

PUBLIC HEARING - DOMESTIC WELL STANDARDS

A motion was made by Fleming, seconded by Graalman and unanimously carried that the Carbon County Board of Commissioners hereby accepts the usage of the Wyoming Department of Agriculture, Explanation of Standards of Potable Water as the acceptable water analytical standards for individual and shared domestic wells in Carbon County.

ROAD & BRIDGE

Roger Pilgrim and County Road & Bridge Supervisor, Don Neuman talked with the Commissioners about County Road #730.

Neuman gave his administrator's report.

The Commissioners signed project agreements for SC-CFM6-48, SC-CFM6-49 and SC-CFM 6-50. The agreements are between Wyoming Department of Transportation and Carbon County.

The Commissioners signed a letter to Joe Yovich of the Wyoming Transportation Department on a proposed SC-CFM gravel project.

A motion was made by Fleming, seconded by Graalman and unanimously carried to approve the following:

A JOINT RESOLUTION OF THE COMMISSIONERS OF CARBON COUNTY, WYOMING AND THE CITY COUNCIL OF RAWLINS, WYOMING, SUPPORTING THE PRONGHORN VISITORS CENTER

WHEREAS, the full development of a National Pronghorn Interpretive Center is in the best interest of promoting an understanding, appreciation and conservation of the unique pronghorn and the Red Desert ecosystem;

WHEREAS, the center will attract students, educators and travel-

WHEREAS, the realization of this project is dependent upon monetary support from agencies outside of Carbon County.
