C.O.V.E.

Linda Torres, representing C.O.V.E. presented a proclamation for the Commissioners consideration.

A motion was made by Fleming, seconded by Graalman and unanimously carried to sign a proclamation recognizing the month of October, 1992 as Domestic Violence Awareness Month and October 5, 1992 as a Day of Unity. (A copy of the proclamation is on file in the County Clerk's office.)

CITY OF RAWLINS

A motion was made by Graalman, seconded by Fleming and unanimously carried to sign a functional classification concurrence letter to develop a urban system and road-way functional classification map for the City of Rawlins.

RATTLESNAKE PASS ROAD

Carolyn Duncan and Don Neuman met with the Commissioners to discuss the Rattlesnake Pass Road. Duncan would like an industrial users designation for County Road 400. With the designation federal match money could be obtained through the Federal Industrial Road Program for improvements.

PLANNING

County Planner, Nina Adams gave her administrator's report.

County Planning Commission member, Irene Archibald reported on the grant they are getting to put together a socio-economic plan for Carbon County.

DOWNTOWN DEVELOPMENT ASSOCIATION

Donna Connor and Della Vivion, representing the Downtown Development Association, requested the County remove the old Silver Spur building. (The building is owned by Carbon County.)

EXECUTIVE SESSION

A motion was made by Fleming, seconded by Graalman and unanimously carried to go into executive session to discuss pending litigation.

COUNTY HEALTH INSURANCE
