SEMINOE DAM ROAD

Willis Larson from the State of Wyoming talked to the Board on damage to the Seminoe Dam Road. He said there is a lot to be done and that the Governor, Mike Sullivan, will be informed of the problem. Emergency Management representatives Nick Casson and Rubyalice Ross were also in attendance for the report.

A motion was made by Graalman, seconded by Fleming and unanimously carried to declare County Road #351 a disaster area. (See following resolution.)

R E S O L U T I O N      1 9 9 1 - 7

WHEREAS, Carbon County suffered damage to roads, bridges, culverts, farmlands, homes, businesses, and other public facilities caused by cloudburts (rain) occurring in pulic land on May 31, 1991 and June 1, 1991;

WHEREAS, the cost of cleanup, repair and replacement of such damaged facilities is far in excess of County resources available.

NOW, THEREFORE, BE IS RESOLVED that the Board of Carbon County Commissioners of Carbon County, Wyoming, declare this to be a disaster area.
