ROAD & BRIDGE

Don Neuman, County Road & Bridge Supervisor, Allen Mace professional land surveyor, and Joe Yovich of the Wyoming Department of Transportation met with the Commissioners to discuss road safety grants for county paved roads and SCCFM fund applications. Zeiger stated he wants completion of the South Road to be a priority item. Yovich and Neuman explained the status of the South Road project.

Yovich suggested the County establish a priority list of two or three projects to be completed with SCCFM funds.

Zeiger inquired about the possibility of upgrading the Seminoe Road with SCCFM money. Yovich assured Zeiger the Seminoe project could be constructed with SCCFM and said preliminary engineering work has been done by the Wyoming Department of Transportation. The Seminoe project could be completed during the 1992 construction season according to Yovich. Yovich agreed to get a cost estimate for the project within seven days.

Yovich said a selection board needed to be established to select a consultant for the South road project. One person from the County has to be selected to be on the board.

PLANNING

Nina Adams, county planning administrator and Allen Mace a professional land surveyor met with the Commissioners to discuss the Ryan Park subdivision proposal and regulatory taking.

A motion was made by Graalman, seconded by Fleming and carried to approve Case File No. 91-09 Zone Change as follows:

Case File No. 91-09 - Zone Change - Sandy's Certified Welding, P. O. Box 142, Encampment, Wyoming, 82325. A Zone Change from RAM (Ranching, Agriculture, Mining) to I (Industrial) to allow for a welding business on a 3 acre parcel legally described as the SW ¼ SE ¼ SE ¼ SE ¼ of Section 36, Township 15 North, Range 84 West, Carbon County, Wyoming.

Allan Mace reported on a rural addressing proposal from William J. Gribb for a computer based mapping system. Graalman recommended meeting January or February with Mr. Gribb.

EXECUTIVE SESSION

A motion was made by Graalman, seconded by Fleming and carried to go into executive session (2:40 p.m.).

A motion was made by Fleming, seconded by Graalman and carried to come out of executive session (3:15 p.m.).

MUSEUM BOARD

Members of the Carbon County Museum Board met with the Commissioners to discuss a planning study for the museum. The Museum Board requested the County sponsor them in an application for grant monies to complete the planning study. The County agreed to support the Museum's effort to obtain the grant. A hearing was scheduled for January 7, 1992 at 10:30 a.m. in the Commissioner's meeting room of the Courthouse.

ROAD & BRIDGE

Don Neuman, County Road & Bridge Supervisor discussed the exhaust exchange system at the Rawlins Shop and the donation of sick leave by Road & Bridge employees.

A lease agreement was signed for the gravel pit on Miller Ranch Co. land.

Neuman reported that Richard Gregory of the Town of Hanna Street Department requested the Town of Hanna be paid for keeping the County road plowed to the Calvert Addition of Hanna. The Commissioners denied the request.

Also discussed by Neuman was the possibility of installing a timber bridge at Elk Mountain.

THERE BEING NO FURTHER BUSINESS, the meeting was adjourned.
