

**REPORT TO THE

Tuesday, November 7, 2017
Carbon County Courthouse, Rawlins, WY**

The regular meeting of the Board of Carbon County Commissioners (BOCC) commenced Tuesday, November 7, 2017 at the Carbon County Courthouse, Rawlins, WY. Attending the meeting were; Chairman John Johnson; Vice Chairman Lindy Glode; Commissioners Leo Chapman, John Espy and Sue Jones.

Chairman Johnson called the meeting to order at 9:00 a.m.

ADDITIONS / CORRECTIONS

Clerk Bartlett reported that Joe Parsons will appear to get final approval of the Boozier Creek grant application and that the amount of notice of valuation changes increased.

CONSENT AGENDA

Commissioner Glode moved to approve the consent agenda which includes the October 17, 2017 regular meeting minutes; Clerk of District Court monthly receipts for September 2017 in the amount of \$1,677.44, County Clerk monthly receipts for October 2017 in the amount of \$21,031.00; bonds for Marie Martin, Trustee for Medicine Bow Rural Health Care District for \$5,000 and Pamela Thayer, Treasurer for the City of Rawlins for \$25,000 and notice of valuation changes for a net total of -\$956,228.00. Commissioner Chapman seconded and the motion carried unanimously.

Buildings & Grounds

Building Manager Jim Piche reported he will ask for substantial completion on the new fire building at Ryan Park at the next meeting. The Ryan Park Volunteers have offered to help fund the interior finish work.

Mr. Piche reported he received the following quotes for carpet at the Rawlins Library and that the Library Foundation will pay for this. Woodward & Associates \$19,883.00; Interior Galore \$19,146.00; and Commercial Carpet Laramie \$16,800.00.

Mr. Piche reported the door mechanisms on the Carbon Building elevator are worn and for \$2,500 he can purchase the parts from the Carbon County School District #1 rather than directly from Kone Elevators for \$14,000. The BOCC agreed he should move forward.

Mr. Piche presented quotes for new carpet in the County Attorney's Office from Woodward and Associates \$12,885.00; Interior Galore \$22,207.13 and Commercial Flooring Laramie \$11,550.00. He recommended accepting the low bid because the local contractor may not have a carpet layer but we will know later today.

Commissioner Glode moved to award the bid to Woodward & Associates for \$12,885.00 contingent upon their ability to lay the carpet and to the lowest bidder with Commercial Flooring Laramie should Woodward not be able to lay it. Commissioner Jones seconded and the motion carried with Commissioner Jones, Glode and Chapman voting for the motion and Chairman Johnson and Espy voting against the motion.

Mr. Piche reported that he will have a formal open house at the Fairgrounds kitchen soon.

IT

Matt Webster, IT Director presented the Union Wireless Agreement for approval.

Commissioner Espy moved to authorize the Chairman's signature on the Enterprise Alliance Calling Plan, a change in plan terms with Union Wireless. Commissioner Glode seconded and the motion carried unanimously.

Public Health

Amanda Brown, Public Health Nurse reported on services her office has provided the past month. She mentioned there will be a new suicide prevention program from the state however she wasn't sure what that would look like at this time.

Planning & Zoning

Sid Fox, Planning Director and Sarah Hutchins, GIS Specialist discussed the 2020 Census and LUCA meeting update. Basically the Census Bureau requests local agencies update addresses in anticipation of the 2020 census. The data is confidential and the pair asked the BOCC to determine who would be allowed to see it recommending it be Sarah, Sid and someone from IT, likely Matt Webster.

Commissioner Glode moved to authorize the authorized census users as Sarah Hutchins, Sid Fox and Matt Webster. Commissioner Jones seconded and the motion carried unanimously.

Boozier Creek FEMA Grant Application

Joe Parsons of the Saratoga Encampment Rawlins Conservation District presented the Federal Emergency Management Agency (FEMA) grant application applying for funds to repair the

Boozier Creek area. Mr. Parsons reported that 25% of the funding will be paid for from the Conservation District, via other state grants they had already applied for.

Commissioner Espy moved to ratify the Chairman's signature on the Disclosure of Lobbying activities for the Boozier Creek Project. Commissioner Chapman seconded and the motion carried unanimously.

Clerk Bartlett reported that the application specifically asks the following: Please identify the entity that will perform any long-term maintenance and provide a maintenance schedule and cost information. The subapplicant or owner of the area to be mitigated is responsible for maintenance (including costs of long-term care) after the project is completed. She wanted the BOCC to be aware that this would commit the county to long-term care. Mr. Parsons stated they typically don't have any long-term maintenance and shouldn't be a problem adding that they will provide grant assistance and he would foresee everyone working together in the future. The BOCC opted to proceed.

Road & Bridge

Bill Nation, Road & Bridge Superintendent presented the Memorandum of Agreement Among the Federal Highway Administration, The Wyoming Department of Transportation, The Wyoming State Historic Preservation Office, Carbon County, the Little Snake River Museum Regarding Mitigation and Adverse Effects to 48CR10573, Savery Creek Bridge WYDOT Project CN06066. He noted that Attorney Davis is reviewing this and there will likely be changes by other agencies.

Commissioner Espy moved to authorize the Chairman's signature on the Memorandum of Agreement Among the Federal Highway Administration, The Wyoming Department of Transportation, The Wyoming State Historic Preservation Office, Carbon County, the Little Snake River Museum Regarding Mitigation and Adverse Effects to 48CR10573, Savery Creek Bridge WYDOT Project CN06066 contingent upon other agencies review. Commissioner Chapman seconded Commissioner Glode asked if Mr. Morgan will have a chance to review the agreement and Mr. Nation said possibly and offered to send it to him. The motion carried unanimously.

Mr. Nation reported crews are back on 8 hour shifts. He recently met with a Pacificorp representative to tour wind projects and the Aeolus substation project. There are contractors present now and he has been in contact with some potential contractors regarding gravel and water sources. His crews continue to help ranchers remove cattle from high country.

Attorney

Ashley Mayfield Davis, Deputy County Attorney reported she attended the prehearing conference for the Boswell Springs project. The hearing is November 20 and 21 and she would expect the county to be late Monday or Tuesday for testimony and they would like as few witnesses as possible and the county's should likely be the Chairman. The three issues for

consideration are conditions for a permit, whether the request is in compliance with state law and rules and what unmitigated impacts may be experienced.

Attorney Davis presented a Lease Agreement Renewal for 523 Rodeo St., Rawlins, WY between Carbon County and Craig Jones for a period of December 1, 2017 to November 30, 2018 in the amount of \$400.00 per month for rent of the groundskeeper's house.

Commissioner Espy moved to authorize the Chairman's signature on the Lease Agreement Renewal for 523 Rodeo St., Rawlins, WY between Carbon County and Craig Jones for a period of December 1, 2017 to November 30, 2018 in the amount of \$400.00 per month for rent of the groundskeeper's house. Commissioner Chapman seconded and the motion carried unanimously.

Attorney Davis provided the Carbon County Museum Memorandum of Understanding for approval.

Commissioner Chapman moved to authorize the Chairman's signature on the Carbon County Museum Memorandum of Understanding. Commissioner Jones seconded and the motion carried unanimously.

Ms. Davis reported that the City is currently reviewing two agreements with the county. One for the shared GIS person and the other for shared IT resources. She expects these to be at a future meeting.

Clerk

County Clerk, Gwynn Bartlett reported that the maximum limit employees can deposit into their flexible spending accounts formerly was \$2,600 and now can be \$2,650 if approved by the BOCC. She requested the BOCC sign the amendment required for this.

Commissioner Jones moved to authorize the Chairman's signature on the Medical Flexible Spending Account Amendment to increase the limit to \$2,650 effective January 1, 2017. Commissioner Glode seconded and the motion carried unanimously.

Clerk Bartlett presented the proposed 2018 Carbon County Commissioners Meeting Schedule and a resolution changing three meeting dates.

Commissioner Glode moved to approve Resolution 2017-30 Amendment Number 5 (Five) to Resolution 2013-12, A Resolution of the Board of County Commissioners of Carbon County, Wyoming Setting Meeting Schedules moving the July 17, 2018 meeting to Monday, July 16, the August 21, 2018 meeting to August 28, 2018 and the November 6, 2018 meeting to November 13, 2018. Commissioner Chapman seconded and the motion carried unanimously.

Clerk Bartlett reported that she and Elections Deputy Lisa Smith ran the recent Rawlins Elementary School student council election to try to reach children early and teach them about voting. She stated the cost was approximately \$50 and her office paid for it. Clerk Bartlett feels by teaching children through school using real equipment and real ballots, the process of registering and voting when they are of age may be less intimidating. She would like to try to reach out to the Middle and High schools to do the same for them.

She discussed the potential use of P-Cards, otherwise known as purchase or procurement cards. She stated she would like to use these to replace the county's current debit cards both for security and convenience. The county would receive rebates back at a percentage of what is expended. Cards could be used for travel, internet orders and generally paying invoices. She has checked with the county's auditors who had no issues. Gwynn mentioned if the BOCC was willing to move forward she would work on a policy for the use of the cards for the board's consideration.

Clerk Bartlett reported that Cathy MacPherson completed meetings with the county's emergency volunteers to review the volunteer policy recently adopted by the BOCC. Her office is mailing policies and receipt forms to all individuals who did not attend a meeting and also to all county appointed board members. The policy will be incorporated into the county's board appointment process and paperwork for new volunteers in the future.

Clerk Bartlett asked if the BOCC will be holding a meeting with department heads and legislators prior to the session, during the session in Cheyenne or both.

Carbon County Economic Development Corporation

Cindy Wallace, Executive Director of Carbon County Economic Development Corporation provided an update on current projects and reported on the Visitors Council. EDC will continue its Leadership Carbon County 2018 class in January through July 2018.

Planning & Development

Public Hearing – C.U. Case #2017-04 Sprint and Edith Davis

Chairman Johnson opened a public hearing at 11:02 a.m. to hear Planning & Zoning C.U. Case # 2017-08 InSite Towers Development 2, LLC. Sid Fox, County Planning Director presented the condition use permit for a telecommunications tower located at the Wagonhound Rest Area Communications Site. Irene Cook discussed the design for these and similar sites noting there would be a 6' security fence and that if this particular tower were to fall it would clear the lagoon. The Town of Elk Mountain had concerns and Chairman Johnson asked how those were addressed. Ms. Cook stated the main concern was that they felt the focus would be Wagonhound rather than their town. She added that Verizon is committed to pursuing the Elk Mountain site however there are regulatory issues to be worked through prior to completion of that tower.

Memorial Hospital of Carbon County (MHCC)

Dana Barnett, Chief Executive Officer for Memorial Hospital of Carbon County and Chelle Keplinger, Chief Financial Officer for MHCC reported on September 2017 financials. Board member Sherrod France was also present. They reported they have recently hired a physician's assistant, nurse practitioner and two doctors.

Mr. France reported that the board of trustees is to follow through with a plan for a hospital district next year to help with physical plant improvements. Their second priority is to investigate an affiliation, a lease or sale of the hospital.

OPIATE CRISIS

Jason Edward Ochs, of the Ochs Law Firm, provided educational material and statistics on the opioid epidemic and exhaustion of public resources towards this crisis. He suggests that his firm can litigate with the top nine opiate manufacturers for potentially billions and that there will be zero up front litigation costs but if there is a recovery in the end there will be a fee. No recovery, no fees. The contingency fee for the five firms working on this will be 25% of any recovery. The team is 35 attorneys and 100 paralegals and Chairman Johnson asked where the funds to litigate will come from. He mentioned two firms are financing the litigation, one from California and one from New York. He offered meetings with those two if requested. Mr. Ochs noted they anticipate litigation to be 5-7 years.

Mr. Ochs stated the first goal is to extract enough money to make them change their practices and goal two is to try to motivate the US Attorney General to go after some individuals criminally.

Commissioners Discussion

Commissioner Jones reported the Dixon Airport Beacon Project is awaiting the tower and hopefully that will be completed soon. As of October 6 there is GPS instrument approach into the airport.

Chairman Johnson reported he met with an energy company who will be drilling in Sweetwater and Carbon counties soon. He toured the Bennett Mountains with the wilderness study group recently. He also recently spoke with some college students about the wilderness study process.

EXECUTIVE SESSION

Commissioner Espy moved to go into executive session at 1:04 p.m. with Ashley Mayfield Davis, Gwynn Bartlett and Jim Piche to discuss personnel, potential litigation and other matters

considered confidential by law. Commissioner Chapman seconded and the motion carried unanimously.

Jim left the session at 1:19 p.m.

Commissioner Espy moved to come out of executive session at 1:27 p.m. noting no action was taken and that the minutes be signed and sealed. Commissioner Glode seconded and the motion carried unanimously.

Commissioner Espy moved to adjourn the meeting at 1:28 p.m. Commissioner Jones seconded and the motion carried unanimously.
