A motion was made by Graalman, seconded by Zeiger and carried to adopt the findings of fact and order as drafted by hearing officer Eric Easton and appoint Bob Grieve, Karen Buchanan, James A. York Sr., Elmer Peterson, and Stewart Quealy or such three of them as agree to serve in the capacity of viewers and appraisers, and to pick a date convenient to them to conduct their duties under the statute.

### **KUHN PRIVATE ROAD**

A motion was made by Graalman, seconded by Zeiger and carried to appoint Bob Grieve, Karen Buchanan, James A. York Sr., Elmer Peterson, and Stewart Quealy or such three of them as agree to serve in the capacity of viewers and appraisers, and to pick a date convenient to them to conduct their duties under the statute.

### **U.P.R.C. SETTLEMENT AGREEMENT**

A motion was made by Graalman, seconded by Zeiger and carried to approve the terms of a settlement agreement as drafted by Bruce Salzberg.

### **COOPERATIVE EXTENSION**

Extension Agent Ruth Wilson introduced the new 4-H Extension Agent, Warren Crawford to the Board of Commissioners.

A motion was made by Graalman, seconded by Zeiger and carried to approve an extended professional agreement for the 4-H extension agent.

A motion was made by Graalman, seconded by Zeiger and carried to approve a certificate of compliance for the Carbon County 4-H agent agreement.

The Commissioners agreed to participate for one year in a new project proposed by the University of Wyoming, at no charge to the county, to provide human services Internet connection in the Extension office.

### **HANNA FIRE DEPARTMENT & EMT SERVICE**

Dick Gregory, representing the Hanna Fire Department and EMT Service, presented an ambulance purchase proposal for the Commissioners consideration. The ambulance would be partially paid for with 1% capital facilities tax money. Zeiger and Graalman agreed to support the proposal.

### **EMPLOYEE LIFE INSURANCE**

A motion was made by Graalman, seconded by Zeiger and carried to change the employee life insurance carrier to Guarantee Life effective November 1, 1998.

### **ADJOURNMENT**

The Commissioners adjourned at 12:00 noon for lunch.

The Board reconvened at 2:00 p.m. following a break for lunch.

**PLANNING & DEVELOPMENT**

Henry Hewitt and Jonathan Schnal presented an administrative report for the Planning Commission.

**SENIOR SERVICES BOARD**

A motion was made by Graalman, seconded by Zeiger and carried to appoint Dixie Shea as the Hanna representative to fill a term ending March 3, 2001 on the Carbon County Senior Services Board.

**CARBON BUILDING**

Ralph Johnson of Johnson Controls appeared before the Board to clarify invoicing for the demolition and relocation of air-conditioning units on the roof of the Carbon Building.

**ROAD & BRIDGE**

County Road & Bridge supervisor, Bill Nation reported the following:

Underground fuel storage tanks have been pulled out at the Rawlins yard, and the above ground storage system is under construction.

Six culverts have been installed near Tullis on the Brown's Hill Road, County Road #602. Two additional culverts are due to be set and gravel will be also be hauled to the area, weather permitting.

The removal of two large beaver dams in culverts at Savery and Dirty Man Creeks and patching have improved road conditions along the South Road, County Road #401.

In the Hanna-Medicine Bow area, crews have bladed out ruts again and helped several ranchers out with cattle trucks on County Road #291 (Hanna/Leo Road).

In the Saratoga area crews have put up several road signs, and installed a cattle guard and gate on County Road #660 (French Creek Road); and finished slopes, fencing and bladed several sections along County Road #504 (Hay Creek).

In the Baggs area crews bladed the Dad-Wamsutter Road, County Road #701 and several school bus routes. A bridge approach was repaired. Broken pieces of concrete sidewalk at the Baggs Senior Center were removed.

A motion was made by Graalman, seconded by Zeiger and carried authorizing the Chairman of the Board of Carbon County Commissioners to sign documents, to be presented by county civil attorney Wade Waldrip, conveying real property along County Road #101 (Elk Mountain).

**HANNA OVERPASS PROJECT**

Gary Steele of PMPC updated the Commissioners on the Hanna overpass project.

A motion was made by Graalman, seconded by Zeiger and carried to enter into project agreement IRP-6-95 with the Wyoming Department of Transportation.

**SEMINOE ROAD**

Bill Nation, County Road & Bridge supervisor, reported on Phase II of the Seminole Road project.

**R.C.R., INC. VS. CARBON COUNTY**

A motion was made by Graalman, seconded by Zeiger and carried authorizing Carbon County Civil Attorney, Wade Waldrip to formally accept service of process in the matter of R.C.R., Inc. a Wyoming Corporation; Jon R. Gray and Martha K. Gray, Plaintiffs vs. Board of County Commissioners, Carbon County, Wyoming, Defendant.
