## **CLERK**

Alice Garvin reported on proposals for refurbishing the elevator in the courthouse from Montgomery Kone and Otis. Montgomery Kone bid \$55,271.00 plus electrical work and contractors work. A verbal bid from Otis was received in the amount of \$70,000.00 plus electrical and contractors work.

A motion was made by Linda Fleming and seconded by Lee Meacham to accept the proposal from Montgomery Kone for the \$55,271.00 for refurbishing of the elevator in the courthouse. The motion carried unanimously.

It was decided to hold the proposal from Techniscan for overseeing the repairs to the courthouse roof until the next regular meeting in December.

A motion was made by Lee Meacham and seconded by Linda Fleming to accept the Fire Strike Team Policy as written. The motion carried unanimously.

## **FIRE STRIKE TEAM FUND POLICY**

1. The Fire Strike Team Fund will be created within the General Fund budget. The approved 1999-2000 amount in the grants fund will be moved to the newly created fund.
2. The new fund will be called the Fire Special Fund. All expenses will be tracked through the fund. At the end of the 1999-2000 fiscal year, the correct fund balance remaining and the projected new income from the Fire Strike Team efforts will be budgeted through such special fund.
3. All income from the Fire Strike Team efforts will be receipted in the County Clerk's Office through the Acceptance Agreement procedure required for receipting of county funds. The receipt along with the funds will be given to the Treasurer's Office for deposit and fiscal management.
4. The Treasurer will invest the net funds in a money market or other appropriate investment to gain interest on the funds. Such will be in a

separate account. The Treasurer will transfer funds from the separate account to cover expenditures made through the special fund. The net interest will be accounted for in such account. The account balance may not exceed \$300,000.00. In the event the Fire Strike Team efforts should have income over \$300,000.00 in any given year, the Commissioners will determine use of such funds. Funds requested by the County Fire Warden to cover expenditures, and/or match for grants or other matters on behalf of the County Fire Department may be expended upon approval by the County Commissioners.

5. The County Commissioners each year will approve or disapprove the fund as it would any other fund in the General fund.
6. There is no budget amendment required, as the funds were approved in the current budget.
7. Any major equipment repairs incurred by the County Fire Department will be paid from the Fire Special Fund, or reimbursed to Carbon County.

A motion was made by Linda Fleming and seconded by Lee Meacham to approve the permit application form for a septic system in the Baggs Events Center. The motion carried unanimously.

Bill Nation presented his bi-monthly report to the commissioners.
