## **CLERK**

Linda Smith, County Clerk, reported that a proposal for the well at the McFadden Fire Station was received by Dwight France. However, The Commissioners requested that the well project be advertised for public bids.

A motion was made by Linda Fleming and seconded by Lee Meacham to allow Chairman Zeiger to sign the contract between Carbon County Public Health and the Department of Family Services, Community Services Block Grant, in the amount of \$49,784.00. The motion carried unanimously.

## **ROAD & BRIDGE**

A motion was made by Lee Meacham and seconded by Linda Fleming to allow Chairman Zeiger to sign a contract for pressure testing of the elevator in the Carbon Building by Montgomery Kone. The motion carried unanimously.

Bill Nation presented his bi-monthly report to the Commissioners.

## **CONSERVATION DISTRICTS**

A motion was made by Linda Fleming and seconded by Lee Meacham to sign a letter of endorsement from the conservation districts of Carbon County for cooperating agency status for Conservation Districts during the Medicine Bow National Forest Revision Plan. The motion carried unanimously.

## **PREDATORY ANIMAL CONTROL BOARD**

A motion was made by Linda Fleming and seconded by Lee Meacham to draft and sign a letter of support for the Predatory Animal Control Board to apply for funding from the Wyoming Animal Damage Management Board. The motion carried unanimously.
