BAGGS AMBULANCE

Ron Taylor of the Noyes Clinic approached the Commissioners concerning the liability coverage of the ambulance EMT's in the Little Snake River Valley.

A motion was made by Linda Fleming and seconded by Lee Meacham to establish Little Snake River Valley Emergency Medical Services as a department of Carbon County. The motion carried unanimously.

RECESS

Recess was called at 7:40 p.m. for the purpose of viewing the recent remodeling at the Noyes Clinic. The meeting resumed at 8 p.m.

COUNTY MAP

Bill Nation, Road & Bridge Department, reported the rural addressing system is dependent upon the County Map process currently underway, and will not be undertaken until litigation on some of the roads is completed.

HIGH SAVERY DAM PROJECT

Larry Hicks advised the Commissioners on the status of the High Savery Dam Project, and requested the Commissioners write a letter of support of the project to the Wyoming Game and Fish Department. The Commissioners took the request under advisement.

BAGGS LANDFILL

Lynn Updike, former Mayor of Baggs, asked the Commissioners to address the operating hours of the Baggs Landfill. The Commissioners agreed to relay his concerns to the Baggs Solid Waste Disposal District Board.

MINUTES

A motion was made by Lee Meacham and seconded by Art Zeiger to accept the minutes of the March 7, 2000 meeting. The motion carried unanimously.

CLERK

Linda Smith presented monthly receipts from the Clerk, Treasurer, and Road & Bridge Departments, and a bond for Courtney Bohlender, She also advised the Commissioners of progress on the elevator and window replacements for the Courthouse.

A motion was made by Lee Meacham and seconded by Linda Fleming to approve Grant Draft Request #005 to the State Land and Investment Board in the amount of \$37,115.90 for the McFadden Fire Station. The motion carried unanimously.

The Clerk also advised the Commissioners that Civil County Attorney Tom Thompson reviewed the AIA Contract proposed by Techniscan for the courthouse roofing project. Mr. Thompson would like to discuss the possibility of using a standard construction contract rather than an AIA with Bob Lindsey of Techniscan. A walk through of the project with bidders is scheduled for March 23, 2000.

A motion was made by Linda Fleming and seconded by Lee Meacham to notify Rawlins National Bank that the new voting system is in place and payments to Global Election Systems may begin. The motion carried unanimously.

ROAD & BRIDGE

Bill Nation presented his bi-monthly report to the Commissioners.

A motion was made by Linda Fleming and seconded by Lee Meacham to sign a notice of appeal to BLM concerning its mandate for a 9 a.m. starting time on the Seminoe Dam Road Project. The motion carried unanimously.

EXECUTIVE SESSION

A motion was made by Linda Fleming and seconded by Lee Meacham to move into Executive Session at 8:55 p.m. to discuss pending litigation. The motion carried unanimously. A motion was made by Lee Meacham and seconded by Linda Fleming to come out of Executive Session at 9:23 p.m. The motion carried unanimously.

Being there no further business, the meeting was adjourned at 9:25 p.m.
