**COUNTY CLERK**

A motion was made by Lee Meacham and seconded by Linda Fleming to re-appoint Mary Apple to a three-year term on the Old Pen Joint Powers Board. The motion carried unanimously.

A motion was made by Linda Fleming and seconded by Lee Meacham to accept the minutes of the April 18, 2000 meeting as written. The motion carried unanimously.

A motion was made by Linda Fleming and seconded by Lee Meacham to award the maintenance of the park north of the Carbon Building and north of the Senior Center to Phyllis McCann at \$550.00 per month. The motion carried unanimously.

A motion was made by Linda Fleming and seconded by Lee Meacham to authorize Chairman Zeiger to sign the final plat of the Saratoga Cemetery Second Addition. The motion carried unanimously.

A motion was made by Linda Fleming and seconded by Lee Meacham to declare a list of excess furniture compiled by the County Clerk as surplus to be offered to other County departments and then for low bid to County employees and non-profit agencies. The motion carried unanimously.

**ELECTED OFFICIALS**

A motion was made by Lee Meacham and seconded by Linda Fleming to accept the bid from Energy Construction of \$1,380.00 to move an office door in the Treasurer's office. The motion carried unanimously.

Sheriff Colson received approval from the Commissioners to expend \$864.00 for security alarms for each office in the Courthouse.

**SENIOR CENTERS**

Bill Michie of the Senior Centers presented his monthly report to the Commissioners. The proposal of \$200.00 per month for the Senior Center lawn care was awarded to Phyllis McCann.

**LONG MECHANICAL SOLUTIONS**

A motion was made by Lee Meacham and seconded by Linda Fleming that the Rawlins Fire Department be permitted to set fireworks off on County property for the Fourth of July Holiday. The motion carried unanimously.

**COUNTY ATTORNEY**

A motion was made by Linda Fleming and seconded by Lee Meacham to go into Executive Session at 11:31 a.m. to discuss pending litigation. The motion carried unanimously. A motion was made by Lee Meacham and seconded by Linda Fleming to come out of Executive Session at 11:45 a.m. The motion carried unanimously.

Chairman Zeiger declared recess for lunch at 11:56 a.m.

Chairman Zeiger brought the meeting back to order at 1:30 p.m.

### **EMERGENCY MANAGEMENT**

Greg Zabel presented his proposal for a computer system for use by Emergency Management from Gateway. The Commissioners authorized expenditures for the system from this year's budget.

### **FIRE DEPARTMENT**

Dwight France approached the Commissioners concerning a spare ambulance in Saratoga that could be donated to the County for use in Ryan Park. More information will be needed before the Commissioners proceed on the issue.

Mr. France also inquired if a portion of the unused Farm Loan Board monies for Ryan Park could be used to complete and install a restroom. The Commissioners advised Mr. France to check into the costs for such a venture. The Clerk was to clarify with the State Land and Investments Board if the funds were indeed available to complete a bathroom.

Bill Nation presented his bi-monthly report to the Commissioners.

A motion was made by Lee Meacham and seconded by Linda Fleming to adopt the electric fence permit form as a policy from the Road & Bridge Department. The motion carried unanimously.

A motion was made by Linda Fleming and seconded by Lee Meacham to sign the final agreement on the Carbon County Road 730, Paintbrush Road. The motion carried unanimously.

A motion was made by Lee Meacham and seconded by Linda Fleming to authorize Chairman Zeiger to sign Grant Draft Request #6 to the State Land and Investment Board in the amount of \$25,325.94 for the North Hanna Access Road. The motion carried unanimously.
