## **BUDGET**

The budget for Fiscal Year 2000-2001 was presented by County Clerk Linda Smith.

A motion was made by Lee Meacham and seconded by Linda Fleming to approve The Resolution to Provide Income Necessary to Finance the Budget and The Budget Resolution for fiscal year 2000-2001 in the amount of \$10,787,190 which includes a mill levy for 12 mills to finance the budget. The motion was carried unanimously.

A motion was made by Linda Fleming and seconded by Lee Meacham to approve the budgets of the Fair Board (0.273 mill), Museum (0.145 mill), Jeffrey Center (0.201) and Library (0.762). The motion carried unanimously.

A motion was made by Linda Fleming and seconded by Lee Meacham to approve the budget for the Weed and Pest District as presented. The motion carried unanimously.

## **CLERK**

A motion was made by Lee Meacham and seconded by Linda Fleming to accept the minutes of the June 13, 2000 meeting. The motion carried unanimously.

Bonds were approved for Heidi Custis, Theresa C. Pacheco and Laura Jean "Sue" Jones.

### **TREASURER**

Cindy Baldwin reported that rebate checks for valuation changes are not being cashed by Amoco. Outstanding checks include one for \$18,000.00. She will be following up on this.
