RESOLUTION 2000-6

A RESOLUTION APPROVING AND ADOPTING THE CARBON COUNTY ZONING RESOLUTION OF 2000

WHEREAS, The Carbon County Planning Commission undertook the task of drafting a set of zoning regulations, known as the Proposed Zoning Resolution of Carbon county, held public hearings on June 20 in Hanna, Baggs on June 22, Saratoga on June 27 and in Rawlins on June 29, 2000, took public comments, incorporated those comments into the proposed zoning resolution, and reviewed for legal adequacy, has produced a final proposed Zoning Resolution of 2000; and,

WHEREAS, The Carbon County Planning commission, at a regularly scheduled public meeting on July 11, 2000, recommended for approval by the Carbon County Commissioners the Zoning Resolution of 2000; and

WHEREAS, The Carbon County Planning Commission submitted the final proposed Zoning Resolution of 2000 to the Carbon County Board of commissioners for review and adoption; and,

WHEREAS, on July 25, 2000, the Carbon County Board of Commissioners held a publicly noticed open meeting to accept comments from the public on the recommended Zoning Resolution of 2000; and

WHEREAS, the Board of Carbon County Commissioners, at said public hearing on July 25, 2000, after consideration of all comments received through the zoning Resolution development process, at public hearings and through written submittals from both the public and governmental agencies, did deem the final proposed Zoning Resolution of 2000, as submitted by the Planning commission, to be legally sufficient, that said resolution did address the concerns of the residents of Carbon County, did promote the protection of the public health, safety, and welfare, and represents appropriate planning practices.

NOW, THEREFORE, IT IS HEREBY RESOLVED, That the Carbon County Board of Commissioners on August 1, 2000, hereby approves and adopts the Zoning Resolution of 2000, and that said resolution shall be effective immediately and all prior resolutions in conflict there with are hereby repealed.

RESOLUTION NO. 00-05 A RESOLUTION VACATING A PORTION OF CARBON COUNTY ROAD 191, ALSO KNOWN AS TROUBLESOME ROAD

WHEREAS, the Carbon County Commissioners have received a petition requesting the vacation of a portion of County road No. 191, commonly known as Troublesome Road; and

WHEREAS, pursuant to Wyoming Stat. §24-3-101(c)(1999Ed.), any person desiring the vacation of a county highway shall file in the office of the county residing within twenty-five (25) miles of the road proposed to be vacated and said petition shall consist of a list containing the names and also the known post office address of each person owning or having interest in any land over which the proposed vacation of a county highway is to be made; and

WHEREAS, said petition has been filed with the county clerk containing the names of twelve (12) electors of Carbon County and their addresses, requesting that a portion of the County road No. 191 be vacated; and

WHEREAS, the Carbon County Commissioners have reviewed said petition and have determined that the request for vacation of this specific portion of county road No. 191 does not deny access to the public of any public lands and that all lands adjacent to this road as to the portion requesting to be vacated are privately owned land; and

WHEREAS, the requested vacation would not jeopardize access to any member of the public to other county roads; and

WHEREAS, the County Commissioners have determined that it is in the best interest of the electors of Carbon County to vacate the requested portion of county Road No. 191; and

WHEREAS, the County Commissioners specifically reserve the access right of the area land owners and the right for governmental agencies to retain access to that road for performing central services pursuant to Wyoming Stat. §24-3-101(c)(1999 Ed.);;

NOW, THEREFORE, BE IT RESOLVED BY THE CARBON COUNTY COMMISSIONERS that Carbon County, Wyoming shall vacate that portion of Carbon County Road 191 described as follows:

Starting on the East Section line of Section 7, T.24N., R.18W.,

of the 6th P.M., Carbon County, Wyoming; thence running in a Northerly direction through said Section 7 and into Section 6 of T.24N., R.81W. of the 6th P.M., ending at the end of Carbon County Troublesome Road #191, in the SE1/4 of said Section 6, T.24N., R.81W. of the 6th P.M., Carbon County, Wyoming.

Carbon County specifically reserves the access rights of the area land owners and the right for governmental agencies to retain access through that portion of the vacated road in the performance of essential public services.

WHEREAS, THE BOARD OF COMMISSIONERS OF CARBON COUNTY, WYOMING, by Resolution dated December 4, 1968 attempted to vacate to adjacent landowners that right of way commonly known as the "Old Rawlins-Parco Highway" as more specifically described in that Quitclaim Deed dated May 15, 1925 and recorded in Book 177, Page 251, in the Office of the County Clerk and Ex-Officio Register of Deeds, Carbon County, Wyoming; and

WHEREAS, the Board of Commissioners of Carbon County have determined that it is in the public interest to maintain said right of way as a road for use by the public; and

WHEREAS, the prior attempt to vacate said right of way was not in the best interest of the public.

NOW THEREFORE BE IT RESOLVED that the said Resolution as described hereinabove is hereby rescinded and that said right of way as described in that Quitclaim Deed dated May 15, 1925 and recorded in Book 177, Page 251 in the Office of the County Clerk and Ex-Officio Register of Deeds, Carbon County, Wyoming commonly known as the "Old Rawlins-Parco Highway" shall be maintained as a public right of way for the purposes of public use and for the best interest of the public.
