### **K.I.D.S. BUILDING**

Cheryl Selby, coordinator for early childhood development for the State of Wyoming, approached the Commissioners regarding the possibility of a child care program utilizing either space in the Carbon Building or the K.I.D.S. building, which the County acquired after the dissolution of the K.I.D.S. program. The Commissioners recognized that childcare is a long-term problem, and stated that the proposal will be taken into consideration.

Peggy Colson and Sue Shinkle also approached the Commissioners concerning the possibility of combining their home based day care businesses into a day care center for County employees in the K.I.D.S. building.

The members of the Community Action Agency Tripartite Board for Carbon County will be discussing the child care issues at a meeting on Monday, October 24, 2000 at the County Courthouse and invited everyone to attend. The County Clerk was asked to coordinate information on the child care issue.

### **PLANNING & ZONING**

A motion was made by Linda Fleming and seconded by Lee Meacham to move Case File #00-25 from the table. The motion carried unanimously.

Jerry Michie informed the Commissioners that the bronze saddle statue for the Carbon Building will be completed within the next few weeks. He requested that

the Commissioners dedicate the statue. The statue was donated by the Rawlins High School classes of 1949, 1950, 1951 and 1952 and will be placed in front of the Carbon Building as it was once the Rawlins High School.

A bond for Trent Blankenship, School District Number 1, was approved.

A letter from Sagebrush Senior Center in Encampment with a reply from Carbon County Senior Services was presented to the Commissioners. The request was for a small van to deliver meals.

### **CARBON BUILDING**

An amendment to Lease Agreement No. 8-09284 Vocational Rehabilitation was approved.

Bill Nation approached the Commissioners for signatures and approval numbers for carpet for suites 312 and 312A in the Carbon Building. Floors 'N More received approval for \$2,289.74.

Bill Nation presented his bi-monthly report to the Commissioners.
