CLERK

A motion was made by Linda Fleming and seconded by Lee Meacham to authorize Chairman Zeiger to sign the Memorandum of Understanding for Wyoming County Commissioners Association for coal bed methane. The motion carried unanimously.

Chairman Zeiger requested that the land department keep track of interest shown surrounding the coal bed methane development in Carbon County.

It was reported that the County Clerk contacted Quinn, Richardson and Kucera and discussed obtaining a second opinion with regard to the replacement/repair of the windows in the County Courthouse. Ken Richardson will prepare the opinion and present it at the next Commissioners meeting.

CLERK OF DISTRICT COURT

Lindy Schmidt, Clerk of District Court, approached the Commissioners

concerning child support and wage withholdings, which will now be paid through the State. It has been determined that recipients will receive their money in a more timely manner with the new process.

County Treasurer Cindy Baldwin presented deeds for signature for lots in the Elmo Addition and Veterans Addition in Hanna which were sold to Barbara Linn.

SENIOR SERVICES

Bill Michie presented his monthly report to the Commissioners concerning the operations of Senior Services throughout Carbon County.

STATEMENT 34

Dennis Tschacher came in and discussed the new Statement 34 reporting standards for Carbon County. Statement 34 is proposed to show government entities how to obtain a truer picture of its finances by making financial statements easier. Statement 34 would make counties more comprehensive and run more as a for-profit organization.

ROAD & BRIDGE

Bill Nation presented a pin and certificate to Darrell Richards in honor of his 16 years of service and retirement from the Carbon County Road & Bridge Department.

Superintendent Nation presented his bi-monthly report to the Commissioners.

A motion was made by Lee Meacham and seconded by Linda Fleming to authorize Chairman Zeiger to sign the authorization for continuance of the North Hanna Access Road with BLM. The motion carried unanimously.

A motion was made by Lee Meacham and seconded by Linda Fleming to authorize Bill Nation to work with legal staff to secure easement and access across private land for 1.4 miles of Cherokee Road. The motion carried unanimously.

A motion was made by Linda Fleming and seconded by Lee Meacham to accept the provisions on county roads and construction activities as outlined in the October 31, 2000 letter from the Water Development Commission. The motion carried unanimously.

EMERGENCY MANAGEMENT/ARMORY

Greg Zabel presented his bi-monthly report to the Commissioners on the conditions of building and grounds around the County.

BLM - PILT

Walt George of BLM explained the deficit in the PILT payments for the last fiscal year, and the amount of PILT funds available to Carbon County for FY 2000-2001. The Commissioners asked for recalculation of the proposed PILT funds for this fiscal year to clarify the cuts that were made compared to other counties.

PLANNING & ZONING
