### **COURTHOUSE WINDOWS**

Ken Richardson of Quinn, Richardson & Kucera approached the Commissioners with a report on the replacement/refurbishing of the Courthouse windows. Mr. Richardson summarized each option for the windows, outlining the drawbacks and advantages to each option. Quinn/Richardson recommended storm glazing and refurbishing of the existing windows as far as pricing, energy savings, ease of use, and architectural integrity.

### **PUBLIC COMMENTS**

Bob Johnson of Elk Mountain approached the Commissioners as to the replacement or repair of the local bridge. Because of its historical value, Road & Bridge Superintendent Bill Nation suggested the possibility of moving the bridge downstream, or refurbishing to a point of the registrar limit for historical registration. No final decision has been made as to the bridge.

Al Santilli approached the Commissioners concerning a property tax payment matter regarding the Medicine Bow State Bank Building from several years ago. The Commissioners asked the County Clerk to investigate the situation.

### **CLERK**

The County Clerk reported that no bids for the UL Compliance, range hood replacement were received by the deadline. The Commissioners requested that the Clerk advertise for bids in the Casper Star Tribune.

The District Court Clerk submitted a proposal from Eagle Computer Systems for the upgrade of the Clerk of Court's computer system.

A motion was made by Linda Fleming and seconded by Lee Meacham to allow the District Court Clerk to purchase a computer system from Eagle Computers under Financing Option 1, for \$15,230.00. The motion carried unanimously.

The Public Defenders office will be moving into the Carbon Building soon, however, it is not yet determined which office they will take. Both available offices will require some refurbishing. The Commissioners approved expenses for the move of \$397.50.

A motion was made by Linda Fleming and seconded by Lee Meacham to go into Executive Session at 8:24 p.m. for the purpose of discussing personnel. The motion carried unanimously. A motion was made by Lee Meacham and seconded by Linda Fleming to come out of Executive Session at 8:37 p.m. The motion carried unanimously.

A motion was made by Lee Meacham and seconded by Art Zeiger to authorize the chairman to sign an agreement between the University of Colorado Hospital and Carbon County. The motion carried unanimously.

**ROAD & BRIDGE**

Bill Nation presented his monthly report to the Commissioners.

A motion was made by Linda Fleming and seconded by Lee Meacham to amend the minutes of the October 3, 2000 meeting to reflect that Bill Nation, Road & Bridge, presented his bi-monthly report to the Commissioners. The motion carried unanimously.

**ADJOURNMENT**

Being there no further discussion, the meeting was adjourned at 9:16 p.m.
