CLERK

A motion was made by Lee Meacham and seconded by Linda Fleming to re-appoint Steve Adams and Sonja Collamer to three year terms on the Carbon County Planning and Zoning Commission. The motion carried unanimously.

Bonds were signed for Carol D. Cook and Darlene Schillinger.

A motion was made by Linda Fleming and seconded by Lee Meacham to approve the minutes of the December 5, 2000 Commissioners meeting. The motion carried unanimously.

A motion was made by Linda Fleming and seconded by Lee Meacham to approve the minutes of the November 21, 2000 Commissioners meeting. The motion carried unanimously.

A motion was made by Lee Meacham and seconded by Linda Fleming to enter into long term/special use agreements with The Boy Scouts, The Moyer Model Airplane Club, and Red Cross for Armory use. The motion carried unanimously. Greg Zabel is authorized to enter into short term, single use agreements for the Armory.

A motion was made by Linda Fleming and seconded by Lee Meacham to allow the Whistle Pig Saloon, Saratoga, Wyoming to extend their regular business hours to include the hours of 10 p.m. to 3 a.m. on the night of December 31, 2000. The motion carried unanimously.

RURAL ADDRESSING

Greg Zabel approached the Commissioners for direction on the proposed rural addressing for Carbon County. The Commissioners requested the Mr. Zabel contact sources for preliminary proposals on a GIS System for the County.

ECONOMIC DEVELOPMENT CORPORATION

Ron Kilgore presented a plan whereby the four current statewide economic districts will be reassessed to pair counties with similar economic bases. Carbon and Sweetwater Counties are interested in forming a new Economic Development District to allow the two counties to develop a comprehensive economic development strategy.

ROAD & BRIDGE

Bill Nation gave his regular bi-monthly report to the Commissioners.

Mr. Nation informed the Commissioners that Carbon County has the potential to be declared a disaster area and may be eligible to receive federal disaster funding because of the severe winter weather.

A motion was made by Linda Fleming and seconded by Lee Meacham to declare a pickup box currently at Road and Bridge as surplus, and measures to donate the item to a school program will be undertaken. The motion carried unanimously.

Gary Steele of PMPC Engineering explained Phase IV of the Seminole Dam Road Project to those present. He expects that Phase IV could very well begin the summer of 2001.

A motion was made by Lee Meacham and seconded by Linda Fleming to authorize PMPC Engineering to be the primary engineer on Phase IV of the Seminole Dam Road Project. The motion carried unanimously. A contract proposal will be presented at the second meeting in January, 2001.

Being there no further business, the meeting was adjourned at 8:31 p.m.
