A motion was made by Lee Meacham and seconded by Linda Fleming to cast a vote for crime insurance in the amount of \$2 million, and a \$25,000.00 deductible with Driver. The motion carried unanimously.

BUDGET HEARINGS

Budget requests were heard by the Commissioners from Darrell Stubbs, Carbon County Assessor; Tom Campbell, County Attorney and Linda Ann Smith, Clerk.

BUDGET HEARINGS

Budget proposals were heard from Carbon County Sheriff for the Sheriff's Department, Jail and Radio Technician, Cindy Baldwin for the Motor Vehicle and Treasurer's Offices, Public Health, Jeffrey Center and Emergency Management.

Presentations from the Carbon County Library, Extension office and Coroner were heard by the Commissioners.

Vicki Hitchcock of the Carbon County Library advised the group that at the May 18, 2001 statewide library meeting, it was decided that the entire state would convert to another computer system company. The service could cost approximately \$12,000.00, including the cost of new computers. It was not included in the original Library budget and the Commissioners were asked to include this in the upcoming fiscal year.

CLERK

A motion was made by Lee Meacham and seconded by Linda Fleming to accept the Findings of Fact and Conclusions of Law in the matter of Deline vs. Carbon County. The motion carried unanimously.
