S-1 BUDGET MESSAGE W.S. 16-4-104(d)

The Carbon County 2009 Special Purpose Tax Joint Powers Board was formed in May, 2009 to issue the Special Purpose Tax Revenue Bonds authorized by the electorate of Carbon County in November, 2008 when the Special Purpose One Cent Sales Tax proposition was approved. The Joint Powers Board is composed of members appointed by eight of the ten town councils in Carbon County and a member appointed by the Carbon County Commissioners. After the issuance of the Revenue Bonds in 2009 and 2010, the Board's duties have included approving the municipal funding requests and monitoring both the Special Revenue Tax collections and bond principal and interest payments. In April, 2016 the Board was able to exercise its option to call \$5,000,000 of the 2009 Bond Series using excess tax revenue collections. Each year the most significant expense of the Board is its annual fiscal audit by an independent CPA firm. For the 2016-2017 budget, \$7,500 has been budgeted for this expense. Funds for this expense and other board expenses is generated from the interest earnings from the Special Purpose Tax Collections. This is an increase of \$ 777.00 for 2016-2017 reflecting an anticipated increase in the cost of the audit of \$300.00 and less cash on hand.
