## Phone Systems

Chief Deputy Clerk, Alice Garvin, presented an estimate from Tom Herdt for replacement of the phone systems for the county. The total estimate for budgeting purposes is \$392,000.00, which includes 227 phones and additional wiring. Mr. Herdt also submitted a proposal in the amount of \$8,500.00 for his continued services as a consultant. He offers his services to help prepare requests for proposals for the phone replacements. Commissioner Fleming moved that a letter be sent to Hugh Wolfe of the Bureau of Land Management (BLM) stating that Carbon County will accept the transfer of 1.4 acres of BLM land with a ten-foot buffer around the existing fence for the Carbon Cemetery project. Commissioner Meacham seconded and the motion carried unanimously.

# **JUVENILE JUSTICE**

Susan Lewis of the Juvenile Justice Board presented a Juvenile Accountability Incentive Block Grant contract for the Board's approval.

Commissioner Meacham moved that the Chairman be authorized to sign the Juvenile Accountability Incentive Block Grant contract between the State of Wyoming, Department of Family Services, Division of Juvenile Services and Carbon County in the amount of \$29,033.00 with a cash match from the City of Rawlins in the amount of \$3,226.00. Commissioner Fleming seconded and the motion carried unanimously.

Ms. Lewis also presented the Wyoming County Commissioners OJJDP Non-Participating grant application for the Board's consideration and approval.

Commissioner Fleming moved to authorize the Chairman to sign the Wyoming County Commissioners OJJDP Non-Participating Grant Program, April 2004 Application requesting a total amount of \$70,000.00. Commissioner Meacham seconded and the motion carried unanimously.
