RURAL ADDRESSING

Allen Mace & Nina Adams talked to the Commissioners about rural addressing systems in Carbon County. Mace & Adams wanted to send a letter to all service businesses in the County to see if they would consent to this project. The proposed rural addressing project would cost \$90,000 and be implemented by the University of Wyoming. Mace and Adams will write some regulations for this project.

ROAD & BRIDGE

County Road & Bridge Supervisor Don Neuman gave his administrator's report and presented a letter to Joe Yovich, District Engineer with the Wyoming Transportation Department, for the Commissioner's signatures. The letter requested SC-CFM Project 6-34 be discontinued and authorized the project to be closed.

The Commissioners signed a project agreement (RRP-0600(3) & SC-CFM 6-42 revised project) between the Wyoming Department of Transportation and Carbon County Board of Commissioners. The proposed project will involve construction for the installation of gated flashing light railroad crossing protection at grade railroad crossing on County Road 605.
