CONSENT AGENDA

Commissioner Johnson moved to approve the consent agenda. Commissioner Chapman seconded and Clerk Bartlett noted the consent agenda includes the November 4, 2016 regular meeting minutes; Clerk of District Court receipts for \$2,693.97. Commissioner Chapman asked that the minutes be corrected to reflect County Road #261 changed to US Forest Service Road #261. The motion carried unanimously.

ELECTED OFFICIALS / DEPARTMENT HEADS

Sheriff

Jerry Colson, County Sheriff reported the City of Rawlins donated a command trailer to the county recently to be used for long-term situations that may arise needing a mobile command center. In light of this he would like to replace a 1980 Ford school bus that has been used as the command trailer and asked that this be declared surplus and he would likely include this in the upcoming public auction his office will hold.

Commissioner Glode moved to declare the 1980 Ford school bus VIN: B70HVJD6222 as surplus property. Commissioner Johnson seconded and the motion carried unanimously.

Attorney

Mike Kelly, Deputy County Attorney presented a resolution concerning the dissolution of the Northwest Ryan Park Water and Sewer District (NWRPWASD). The funds remaining will be transferred to the county totaling \$2,746.83. The BOCC set the matter for public hearing

Commissioner Johnson moved to set the dissolution of the Northwest Ryan Park Water and Sewer District at 10:45 a.m. at the County Courthouse in Rawlins WY. Commissioner Jones seconded and the motion carried unanimously.

Clerk

Gwynn Bartlett, County Clerk presented the applicants for the Baggs Solid Waste Disposal District, Brian Lally and Randy Davis.

Commissioner Johnson nominated Brian Lally and Commissioner Jones nominated Randy Davis. Commissioners Johnson and Glode voted for Mr. Lally and Commissioners Jones, Chapman and Chairman Espy voted for Mr. Davis therefore Mr. Davis was appointed for an unexpired term on the Baggs Solid Waste Disposal District ending September 2018.

Clerk Bartlett requested and received approval to hire a replacement for a Deputy Clerk position.

<u>Fire</u>

County Fire Warden John Rutherford presented the grant documents for the Cooperative Agreement for the sub-award of the 2013 Western States Wildland Urban Interface Grant between the Office of State Lands and Investments Wyoming State Forestry Division and Carbon County. This grant allows for private property owners to receive reimbursement for part of the fire fuel reduction work on their properties. He noted that Attorney Kelly reviewed the document and recommends approval.

Commissioner Johnson moved to authorize the chairman to sign the Cooperative Agreement for the sub-award of the 2013 Western States Wildland Urban Interface Grant between the Office of State Lands and Investments Wyoming State Forestry Division and Carbon County. Commissioner Glode seconded and the motion carried unanimously.

Mr. Rutherford reported that after an active fire season his volunteer wage budget is depleted. He informed the board one brush truck will need a rebuilt engine and he will do his best to stay within budget and the BOCC stated that going into this budget they knew there would likely be a need for additional funds for volunteers and they encouraged him to complete necessary tasks and to not sacrifice safety.

Road & Bridge

Bill Nation, Road & Bridge Superintendent reported they continue to blade county roads, especially because this is cattle shipping season. He stated a notice to proceed was issued for the Wild Cow Road #608 from the Congestion Mitigation Air Quality grant staff and there will be a public hearing at the next BOCC meeting regarding the use of these funds. He continues to work on landowner approvals for bridge inspections.

Commissioner Jones read the response from the US Forest Service regarding the potential move of one of their roads, #261, to the county. Basically the US Forest Service is not able to obligate funding towards a study however they have tentatively budgeted over \$11,000 for this project out of their next fiscal year's budget. Commissioner Jones stated WY State Trails still has not responded to a request for funding towards this.

Buildings & Grounds

Jim Piche Buildings Manager reported a potential donor would like to remodel the fairgrounds concession building and this new facility would be capable of cooking meals and transporting them to the multipurpose facility as well. Mr. Piche has secured donated kitchen equipment for the project from the School District to be used in the new facility.

Mr. Piche asked the status of the potential move of the emergency operations center to the fairgrounds can be located at the fairgrounds noting a representative from the BOCC recently met with fair board members. Commissioner Johnson stated they need to find some place to store fair board records but in the interim he felt like the county could store the new mobile command center there.

Mr. Piche is working with the hospital and may team up on contractual services to try to get better pricing. He is working to hire an administrative assistant. Winterization of sprinklers at county buildings in Rawlins has been completed. Survey work is complete at Ryan Park and he will meet with the Army Corp of Engineers next week. He expects no issues but will report at a later date. County Planning Director Sid Fox reported that his office will need to issue a building permit for the proposed county fire station addition at Ryan Park. The existing road is outside the boundary where it should be therefore he feels an easement would correct the issue. This will require cooperation of adjacent property owners which he expects will not be an issue.

Mr. Piche is working towards finding a central records storage site for all county offices to utilize and proposed the east basement room of the Jeffrey Center. This building is centrally located between the Carbon Building and Courthouse and the room is mostly empty. Both the State Fire Marshall and the City of Rawlins have no issues with this plan noting they both feel the space can only be used for something like this and not a public space. He proposed working with county departments and developing a cost estimate to transition the room noting the Jeffrey Center Board would need to approve the request as well. He is trying to get the Jeffrey Center Board to respond to a request for a meeting.

The Department of Environmental Quality has permitted the installation of a leech field for the Dixon Airport pilot's lounge and this will be installed later in October.

PLANNING & ZONING

Public Hearing - Zoning Resolution Amendment (ZRA) Case #2016-01 Text Amendment

Chairman Espy opened a public hearing at 3:00 p.m. to hear Planning & Zoning Resolution Amendment (ZRA) Case #2016-01 Text Amendment Sid Fox, County Planning presented ZRA Case File No. 2016-01, a request to consider proposed amendments to the text to Chapter 3-Definitions and Chapter 4-Zone District Regulations, Section 4.4-Ranching, Agriculture and Mining (RAM) Zone District to allow for animal crematorium in industrial and RAM zones. Mr. Fox noted if a rancher needed to deal with animals on a ranch, this is already a use by right however since an animal crematorium is not on site and part of a ranching operation this is not currently allowed.

Toby Smith stated he serves on a landfill board asked if the animal crematorium would handle animal waste in 2020 when their landfill closes. Mr. Fox reported this could handle it however Katie Hones, the applicant for the conditional use permit stated her intent is for private pet memorial and that all animals will be returned to their owners.

Bill Nation complimented Katie Hones on her cleanup efforts on the property she plans to utilize for this project.

Chairman Espy called for comments for or against the case. There being no comments, Chairman Espy closed the hearing at 3:08 p.m.

Commissioner Glode moved that based on the recommendation of the Planning & Zoning Commission and staff to approve Resolution No. 2016-40, A Resolution of the Board of County Commissioners of Carbon County, Wyoming adopting the recommendation of the Carbon County Planning and Zoning Commission regarding ZRA Case File No. 2016-01, a request to consider proposed amendments to the text to Chapter 3-Definitions and Chapter 4-Zone District Regulations, Section 4.4-Ranching, Agriculture and Mining (RAM) Zone District. Commissioner Chapman seconded and the motion carried unanimously.

Resolution No. 2016 – 40

A Resolution of the Board of County Commissioners of Carbon County, Wyoming, adopting the recommendation of the Carbon County Planning and Zoning Commission to amend the Carbon County Zoning Resolution of 2015.

ZRA Case File #2016-01 (Zoning Resolution Amendment-Text Amendment)

WHEREAS, pursuant to Wyo. Stat. Ann. §18-5-202(b), the Carbon County Planning and Zoning Commission may prepare a comprehensive plan including zoning for promoting the public health, safety, morals and general welfare of the unincorporated area of the county and in accordance with Section 6.8 of the Carbon County Zoning Resolution of 2015, Zoning Resolution Amendments and Zone District\Map Amendments, the Planning and Zoning Commission shall prepare recommendations to effectuate the Planning and Zoning purposes and certify its recommendations to the Board of County Commissioners; and,

WHEREAS, pursuant to Wyo. Stat. Ann. §18-5-202(b), the Carbon County Planning and Zoning Commission scheduled a public hearing for Monday, September 12, 2016, which said public hearing was advertised by public notice at least thirty (30) days prior to said regular hearing date; and,

WHEREAS, prior to the Monday, September 12, 2016, public hearing, the Carbon County Planning and Zoning Commission provided the public the opportunity to comment and the Carbon County Planning and Zoning Commission considered any public comments which were submitted in writing or made at said public hearing; and

WHEREAS, at the conclusion of said Monday, September 12, 2016, public hearing, the Carbon County Planning and Zoning Commission voted to certify in writing its recommendation to the Carbon County Board of County Commissioners to adopt the text amendment to the Carbon County Zoning Resolution of 2015 for Carbon County, Wyoming; and

WHEREAS, the Carbon County Board of County Commissioners provided public notice to review and consider the proposed amendment; and,

WHEREAS, pursuant to Wyo. Stat. Ann. §18-5-202(c) and after receipt of said certified recommendation of this Zoning Resolution Amendment to the Carbon County Zoning Resolution of 2015, as amended for Carbon County, Wyoming, advertised by public notice at least fourteen (14) days prior to a public hearing to take public input and comments on the proposed text amendment, which said hearing occurred on Tuesday, October 18, 2016; and

WHEREAS, at said public hearing, the Carbon County Board of County Commissioners provided the opportunity for the public to comment and for the Carbon County Board of County Commissioners to consider any comments which were made on the proposed text amendment; and

WHEREAS, the Carbon County Board of County Commissioners in considering the proposed text amendment have also reviewed and considered the Carbon County Comprehensive Land Use Plan, as amended; and the Carbon County Zoning Resolution of 2015, as amended; and,

WHEREAS, the Zoning Resolution Amendments are consistent with the Goals and Strategies identified in the Carbon County Comprehensive Land Use Plan as recommended by the Carbon County Planning and Zoning Commission; and

WHEREAS, the Carbon County Board of County Commissioners have determined that the proposed text amendment is in general conformance with the Carbon County Comprehensive Land Use Plan, as amended, and the applicable provisions of the Carbon County Zoning Resolution of 2015, as amended; and otherwise promotes the health, safety and general welfare of the residents of Carbon County; and

WHEREAS, at a regularly scheduled meeting of the Carbon County Board of County Commissioners, by majority vote, the Carbon County Board of County Commissioners moved to approve ZRA Case File #2016-01 – Text Amendment "Animal Crematorium" the Carbon County Zoning Resolution of 2015, as amended, as recommended to them by the Carbon County Planning and Zoning Commission.

C.U. Case #2016-10 - Peterson/Hones - Animal Crematorium

Chairman Espy opened a public hearing at 3:10 p.m. to hear Planning & Zoning C.U. Case #2016-10 – Peterson/Hones - Animal Crematorium Sid Fox, County Planning Director or Thomas Powell, Planner/GIS Specialist presented a request for a Conditional Use Permit in the RAM Zone for the construction, operation, and maintenance of an animal crematorium. The incinerator will be free standing and placed on an existing 23'x23' concrete pad. An air emissions permit from the WY Department of Environmental Quality is necessary for the proposed crematorium however the county must approve the application prior to application for this permit.

Chairman Espy called for comments for or against the case. Katie Hones, applicant spoke for approval of the case. She stated that this is a clean burning unit and the DEQ engineer stated it is exempt from the permit however they must formally state that after application is made. The unit may run 3-5 hours weekly at the current rate. At this time this is not intended for the disposal of mass animal waste and they will not spread ashes. If ashes are abandoned they will be sent to a landfill. There being no comments, Chairman Espy closed the hearing at 3:17 p.m.

Commissioner Glode moved that based on the recommendation of the Planning & Zoning Commission and staff to approve Resolution No. 2016-41, A Resolution of the Board of County Commissioners of Carbon County, Wyoming adopting the recommendation of the Carbon County Planning and Zoning Commission regarding C.U. Case #2016-10 — Peterson/Hones - Animal Crematorium with 8 recommended conditions. Commissioner Chapman seconded and Mr. Fox recommended condition 7 not be included. Resolution No. 2016 – 41

A Resolution of the Board of County Commissioners of Carbon County, Wyoming adopting the recommendation of the Carbon County Planning and Zoning Commission.

C.U. Case File #2016-10- "Animal Crematorium"

WHEREAS, pursuant to the Carbon County Zoning Resolution of 2015, as amended, and Wyo. Stat. Ann. §18-5-202(b), the Carbon County Planning and Zoning Commission held a public hearing on Monday, September 12, 2016, which said hearing was advertised by public notice at least thirty (30) days prior to said hearing; and

WHEREAS, at the Monday, September 12, 2016, public hearing, the Carbon County Planning and Zoning Commission provided the public the opportunity to comment and the Carbon County Planning and Zoning Commission considered any public comments which were made at said public hearing; and

WHEREAS, at the conclusion of the Monday, September 12, 2016, public hearing, the Carbon County Planning and Zoning Commission voted to certify in writing its recommendation to the Carbon County Board of County Commissioners pursuant to the Carbon County Zoning Resolution of 2015, as amended for Carbon County, Wyoming; and

WHEREAS, the Carbon County Board of County Commissioners, pursuant to the Carbon County Zoning Resolution of 2015, as amended, and Wyo. Stat. Ann. §18-5-202(c) and after receipt of said certified recommendation; advertised by public notice at least 14 days prior to a public hearing to take public input and comments which said hearing occurred on Tuesday, October 18, 2016; and

WHEREAS, at said public hearing, the Carbon County Board of County Commissioners provided the opportunity for the public to comment and for the Carbon County Board of County Commissioners to consider any comments which were made on the proposed application; and

WHEREAS, the Carbon County Board of County Commissioners in considering said application have also reviewed and considered the Carbon County Comprehensive Land Use Plan, as amended; and the Carbon County Zoning Resolution of 2015, as amended, specifically, Section 5.4, Conditional Use Permits; and

WHEREAS, the Carbon County Board of County Commissioners have determined that the proposed permit is in general conformance with the Carbon County Comprehensive Land Use Plan, as amended, and the Carbon County Zoning Resolution of 2015, as amended, and otherwise promotes the health, safety and general welfare of the residents of Carbon County; and

WHEREAS, at a regularly scheduled meeting of the Carbon County Board of County Commissioners, by majority vote, the Carbon County Board of County Commissioners moved to approve the following Conditional Use Permit Application:

<u>C.U. Case #2016-10:</u> Request for a Conditional Use Permit in the RAM Zone for the construction, operation, and maintenance of an animal crematorium as more specifically described at the public hearing and in the application.

<u>Petitioners:</u> Katherine Hones, DVM / Hones Veterinary Service LLC (Applicant) and Peterson Livestock LLC (Land Owner)

TERMS AND CONDITIONS OF APPROVAL:

- 1. The Applicant shall submit an approved WDEQ Air Quality Permit to the Carbon County Planning and Development Department.
- 2. The facility must post a sign at the entrance that includes the facility name, the name and phone number of the responsible person in event of an emergency.

- 3. The Applicant(s) shall notify the Carbon County Planning & Development Department in writing of any material changes to the project subsequent to the County issuance of the Conditional Use Permit. Minor modifications to the site, such as the addition of an enclosure may be approved by the Planning Director as part of the building permit approval process.
- 4. In accordance with Section 5.4-E, Expiration of Conditional Use Permits:
 - Any use for which a conditional use permit is granted must be commenced within two (2) years from the date of approval. If the Project is not commenced within two (2) years from the date of approval then the conditional use permit shall expire and become null and void and be of no further effect, except as extended in compliance with Section 5.4(F), Extension of Conditional Use Permits.
- 5. In accordance with Section 5.4-G, Transfer of Conditional Use Permits:
 - No conditional use permit shall be transferred without the prior approval of the Board of County Commissioners.
- 6. In the event the actions occurring pursuant to this permit are found to be in material violation of the terms and conditions of this permit, or are found to have been obtained by fraud, this permit shall be subject to all remedies allowed by law. Violation of any of the above restrictions can be grounds for terminating this Conditional Use Permit.
- 7. C.U. Case #2016-10 is subject to the approval of the companion case file ZRA Case #2016-01-Text Amendment "Animal Crematorium". Removed in Commissioners motion.
- 8. Permit approval for the $\frac{1}{2}$ acre site as represented on the site plan.

<u>Amendments to Conditional Use Permits:</u> A Conditional Use Permit may be amended pursuant to the procedures and standards as required for a new CUP application.

CITIZEN/COMMISSIONERS DISCUSSION

Commissioner Jones asked Mr. Fox to update the BOCC on the Saratoga planning update. Mr. Fox stated there is a small working group that is obtaining buy-in from the town planning commission on the draft memorandum of understanding after which the process will move forward.

Mr. Fox discussed calls he has received on wind energy development and the federal tax credits for alternative energy. Terra Moya northwest of Elk Mountain was permitted for a facility in 1999 but never proceeded and they are set to update the Planning Commission and potentially apply for a new permit.

PUBLIC COMMENT

Bonnie Culver, Medicine Bow Library Manager reported she has had lights to be installed at her facility for over a year and they were finally installed recently and thanked Mr. Piche for making this happen.

Toby Smith, Medicine Bow Senior Center Board President asked if the county will continue to cut funds next fiscal year and asked about cut funding for the local medical center. Commissioner Jones explained the cuts that outside agencies and county departments took and may continue to take. Kenda Colman asked if wind energy tax goes to the general fund of the county because she thought communities impacted by wind energy should be funded by this. Commissioner Jones stated some of the county's money is returned to Medicine Bow through funding to its center, law enforcement and other services the county provides. She contended there was only seven employees of the various wind farms living in the area therefore the impact was not great. The BOCC made it clear they worked hard to fund statutorily required services while still keeping quality of life services in various areas of the county.

Commissioner Chapman reported Carbon County Economic Development will hold a chili cook off fundraiser in Baggs soon.

Commissioner Glode clarified on the budget discussion that the BOCC cares about employees and positions that were cut were done so mostly through attrition, not by layoffs.

Mike Kelly reported he attended the Bureau of Land Management energy conference last week and provided updates on various projects including the Continental Divide Creston project will have 600 gas wells in Carbon County. The Environmental Impact Statement (EIS) on the Gateway West Project has finally been completed and a record of decision will be expected soon.

EXECUTIVE SESSION

Commissioner Johnson moved to go into executive session at 4:18 p.m. with Clerk Bartlett and Mike Kelly to discuss personnel and potential litigation. Commissioner Glode seconded and the motion carried unanimously.

Commissioner Johnson moved to come out of executive session at 4:28 p.m. noting no action was taken and that the minutes be signed and sealed. Commissioner Chapman seconded and the motion carried unanimously.

ADJOURNMENT

Commissioner Johnson moved to adjourn the meeting at 4:28 p.m. Commissioner Jones seconded and the motion carried unanimously.
