CLERK

Minutes

Commissioner Paxton moved to approve the minutes of the October 5, 2010 regular meeting of the Board of Carbon County Commissioners and the minutes of the October 12, 2010 special meeting regarding health insurance of the Board of Carbon County Commissioners as presented. Commissioner Young seconded and the motion carried unanimously.

Bonds

Commissioner Young moved to approve a \$50,000.00 bond for Robert L. Patton, Treasurer in the Carbon County School District 2. Commissioner Paxton seconded and the motion carried unanimously.

Monthly Receipts

Commissioner Young moved to accept the Clerk of District Court receipts for the month ending August 2010 in the amount of \$3,451.11, and month ending September 2010 in the amount of \$3,343.75. Commissioner Paxton seconded and the motion carried unanimously.

Carbon Mercantile Roof

Clerk Bartlett presented a letter from Lindy Glode of the Carbon Mercantile Corporation requesting the County sponsor a grant to repair their roof. She noted that the letter does not indicate the amount of the grant, the agency they will apply to, or if there is a match requirement but that if all these things are deemed acceptable she would agree with sponsorship and would agree to help monitor the grant. Chairman Weickum stated he believes the grant is through the Wyoming Business Council.

Commissioner Paxton moved to authorize Clerk Bartlett to work with the Carbon Mercantile Corporation to clarify information and possibly apply for a grant to repair the building roof. Commissioner Young seconded and the motion carried unanimously.

Board Resignation

Clerk Bartlett presented a resignation from Rita Clark from the Senior Services Board effective October 16, 2010 and stated she will advertise for this position.

Commissioner Paxton moved to accept the resignation of Rita Clark from the Senior Services Board effective October 16, 2010 and to authorize Clerk Bartlett to advertise for a replacement. Commissioner Young seconded and the motion carried unanimously.

Special Districts Annual Report

Clerk Bartlett advised she received a letter from the State of Wyoming, Department of Audit that nine special districts in the County have not filed an annual report that was due September 30, and a copy of the letter has been mailed to each entity. These entities are the Baggs Cemetery District; Baggs Solid Waste Disposal District; Carbon County Predator Management Board, Carbon County School District No. 1 Recreation Board; Carbon County School District No. 2 Recreation Board; Little Snake River Conservation District; Rawlins Downtown Development Authority; Saratoga-Carbon County Impact Joint Powers Board; and Savery-Little Snake River Water Conservancy.

Homeland Security Grant

Clerk Bartlett reported that Sheriff Colson indicated he does not wish to apply for the Interoperable Emergency Communications Grant as Deputy Attorney Kelly reviewed the grant agreement and pointed out that the grant mandates certain responsibilities on the part of the County including a requirement that the County establish a local and/or regional interoperability committee and that the County establish standard operating procedures for use of the interoperability channels.

CMAQ Reimbursement

Commissioner Young moved to authorize the Chairman's signature on the Wyoming Department of Transportation Congestion Mitigation / Air Quality (CMAQ) FY2010 Project Cost Reimbursement Statement for project CM0.00CM10002 in the amount of \$300,964.03 and to authorize Bill Nation to sign the Acceptance and Completion Certificate. Commissioner Paxton seconded and the motion carried unanimously.

ELECTED OFFICIALS / DEPARTMENT HEADS

Attorney

Deputy Attorney Mike Kelly presented a contract for the Community Juvenile Services Board.

Commissioner Paxton moved to approve the Professional Services Contract Between the State of Wyoming, Department of Family Services and Carbon County Board of Commissioners in the amount of \$43,750.00 from September 1, 2010 through June 30, 2012 for the Community Juvenile Services Board with an in-kind match from Carbon County.

Deputy Attorney Kelly reported that the Wyoming Military Department is terminating the lease for the Armory Building and will be leasing it to the Wyoming Department of Corrections who has indicated they will sublease the facility to the County.

He also reported he has been in contact with Peggy Trent who represents the Town of Hanna and has discussed the County's purchase of the Hanna Senior Center and Fire Hall and Ms. Trent should be submitting a purchase agreement within a week. The existing fire service Memorandum of Understanding with Hanna may need to be renewed as it expires at the end of October.

Commissioner Paxton moved that contingent upon legal review, Chairman Weickum be authorized to sign the extension of the Memorandum of Understanding with the Town of Hanna for fire suppression. Commissioner Young seconded and the motion carried unanimously.

Deputy Attorney Kelly reported he has been working with Cathy MacPherson who represents the Platte Valley Community Center Joint Powers Board regarding a potential problem with funding for that center. Ms. MacPherson is going to report back to him on the matter.

Deputy Attorney Kelly has also been working on obtaining proof of insurance for 4-H children to ride in the County's vehicles and he is working with Ms. MacPherson on obtaining changes to the County's Personnel Manual. Clerk Bartlett asked that the other elected officials and department heads have input on any proposed changes.

Assessor

County Assessor Sheryl Snider presented numerous abates and rebates. She reminded the BOCC that January 11 there will be a training offered by the Board of Equalization in Cheyenne.

Sheriff

Sheriff Jerry Colson reported that his office is working on a request for proposals for a new E911 system and he will have Deputy Attorney Kelly review this before releasing it.

Road & Bridge

Bill Nation, Road & Bridge (R&B) Superintendent, reported the Sinclair Bypass is substantially complete. He stated County Road #351 to Seminoe at the Dugway will be part of a high risk rural road program to add striping, signs, and rumble strips to attempt to slow people down. The Savery bridge update is at the Wyoming Department of Transportation for review and upon completion of that it will be replaced. He discussed various meetings he will attend including one regarding the road south of Rawlins and construction that may take place.

Museum

Tiffany Wilson the new Carbon County Museum Director introduced herself.

DIXON AIRPORT

Barry Bryant, Dixon Airport Manager and Steve Marshall, Airport Development Group reported about lease rates at the Dixon Airport. Mr. Bryant stated that \$0.15 per square foot would be more in line with what similar airports charge rather than \$0.25 per square foot per month. He also recommended between now and the end of 2011 waiving the first five years of lease payments to spur development there. Chairman Weickum discussed his concern for lowing rent as well as waiving lease fees. Commissioner Paxton stated the lower lease sounded more reasonable and suggested possibly waiving fees for a lesser period. He also suggested taking County Attorney Cal Rerucha's suggestion to have a work session regarding property at the

airport and the BOCC asked Deputy Attorney Kelly to have Attorney Rerucha set something up for November 9 at 7:00 p.m. in Baggs at the Higher Education Building.

Mr. Bryant discussed several hangars on the County's property and Deputy Attorney Kelly stated that there have been no building permits nor have they been assessed. Mr. Marshall advised he spoke with Mr. Grieve about a price to purchase his hangar and another on the south side of the airport. On the north side are the three hangars on County property.

Brent Wilson requested a lease as soon as possible. Mr. Bryant asked Deputy Attorney Kelly to look at whether or not a fire marshal review is really necessary.

Commissioner Paxton moved to set the rental amount at \$0.15 per square foot per year at the Dixon Airport and to forgive the first 2 years of rent as incentive to get people to build on the property. Commissioner Young seconded and Mr. Wilson discussed a possible sunset date for the incentive on the lease. Mr. Bryant suggested the end of 2011. The motion was amended to add that the two year rent forgiveness is contingent upon the start of construction by December 31, 2011. The amended motion carried unanimously.

Mr. Fox stated he is comfortable issuing the building permit for Mr. Wilson and a zone change may need to be completed before building.

Mr. Bryant stated the UHF license should be received soon and once received the AWOS can be activated. He reported the WY Aviation Capital Improvement Plan will pay for 50% up to \$100,000 for mowing equipment for the Dixon Airport.

The BOCC directed Deputy Attorney Kelly to draft a lease for Mr. Wilson and bring it for approval November 9. Mr. Bryant requested that Resolution #2009-18 be amended to reflect a \$1 million liability requirement and changes in worker's compensation.

CITIZEN DISCUSSION

James Piche of Pioneer Mill Construction reported that he is a victim of the Wy-Con disaster at the Fairgrounds multipurpose facility and asked if the County could push harder to have Wy-Con pay contractors. Deputy Attorney Kelly stated that he spoke with the bonding company yesterday who indicated the compilation of outstanding claims is complete and a certified letter has been sent to Wy-Con requesting notification of their plans. He explained that if there is no response by Wy-Con they will instigate a lawsuit and the County will go into interpleader where the court will take the bond funds and County funds to pay contractors as it deems appropriate.

Tim Bauman of Childress Electric stated that the bonding company has indicated it will not release its funds until the County releases its withholding. He questioned the legality of the small bond on such a large job. Chairman Weickum asked if Mr. Bauman has filed suit against Wy-Con and Mr. Bauman stated that it will cost a large amount to do this. Deputy Attorney Kelly indicated that if contractors were to file suit Wy-Con would have to resolve it. Mr. Bauman stated change orders were done directly for the County and he asked why these haven't been paid.

Mike Sisneros of BCN Construction was also present.

Chairman Weickum stated that the County apologizes, Wy-Con was an incredible disappointment, and the County will do everything it can to pay each contractor whole however no promises can be made.

COMMISSIONER DISCUSSION

Chairman Weickum and Commissioner Paxton reported on meetings they have and will be attending.

PLANNING & ZONING

Certification of the Draft 2010 Carbon County Comprehensive Land Use Plan

Sid Fox, County Planning Director presented the Certification of Recommended Action for the draft 2010 Carbon County Comprehensive Land Use Plan on behalf of the Planning & Zoning (P&Z) Commission. Mr. Fox stated that as a result of the public input the P&Z Commission tabled the plan and did minor edits and he presented copies of the edits.

Commissioner Young moved to schedule a public hearing pursuant to Wyoming Statute 18-5-202(b) and (c) for November 9, 2010 at 3:15 p.m. at the County Courthouse in Rawlins, Wyoming to hear comments for the purpose of determining to adopt the Plan, adopt the Plan with modifications or disapprove of the draft 2010 Carbon County Comprehensive Land Use Plan. Commissioner Paxton seconded and the motion carried unanimously.

Mr. Fox presented a proposed resolution provided by the City of Rawlins regarding an extraterritorial utility and infrastructure expansion plan. He stated this would extend into rural, unincorporated areas of the City of Rawlins and just wanted the BOCC to be aware of it.

OLD PENITENTIARY

Leigh Nation from the Old Penitentiary Joint Powers Board provided a summary of the summer activities at the Old Penitentiary. Also present from the Board was Gary Hansen, Jr., Mary-Pat Whitfield, Leigh Nation, Glenna Kauppila, David Michie, III and Historic Site Director Tina Hill.

Mr. Hansen discussed the upcoming County Commissioners meeting next April and asked if the BOCC had decided if the event would be held at the Old Penitentiary.

COURTHOUSE GROUNDS

Derk Pfannenstiel requested the use of the south side of the Carbon County Courthouse along Pine Street to hold a satellite of the Rally to Restore Sanity held in Washington D.C. on October 30 from 9:00 a.m. to 2:00 p.m. He stated he would provide liability insurance, portable restrooms, and a generator.

EXECUTIVE SESSION

Commissioner Paxton moved to go into executive session at 6:58 p.m. with Clerk Bartlett and Deputy Attorney Mike Kelly to discuss potential litigation and other matters considered confidential by law. Commissioner Young seconded and the motion carried unanimously.

Commissioner Paxton moved to come out of executive session at 7:21 p.m. and that the minutes of the session be approved as written and sealed and declared that no action was taken during the session. Commissioner Young seconded and the motion carried unanimously.

ADJOURNMENT

There being no further business, Chairman Weickum adjourned the meeting at 7:21 p.m.
